Revision Note 2004; About the Front Cover:

This is the revised edition of my book. For the most part the revisions are added and explained in the back of the book. However I wanted to explain the changing of the name on the front cover here.

In most of this book “SMARiTT” is referred to or written as “SMARTT”. It is that way because I left most of the book in its original form. Originally I settled on SMARTT as the acronym to label all of the electronics used to monitor humanity 24 hours a day, 7 days a week, 365 days a year. SMARTT stood for Stealth Monitoring and Recording Telecommunication Technology. SMARiTT stands for the same thing except I added the “i” to stand for “inner”. I did this because I had to revise my book anyway and as I thought about it I decided that emphasizing the ability to monitor a person’s energy from inside their minds and thoughts was very significant and needed to be added to the acronym. I left the “i” in the lower case to intentionally make it stand out and, or make it more particularly noticed.

So for most of the book SMARiTT will be written as SMARTT.

Also, SMARTT was originally pronounced as (*smart*). With the “i” added I suppose it could be pronounced as (*smar it*). However, if you say it fast enough it could still be pronounced as (*smart*). The irony here is that the “i” is invisible either when you say the word fast enough or when they are using the electronic equipment on you in reality from the inside.

(Note: As I thought about it even more, we could just make the “i” silent and when you say it, it would still be pronounced as (*smart*). This way it would still be there, but you wouldn’t know it unless you saw it for yourself, just like the equipment and technology of SMARiTT itself.)

(2010 Revision Note: Since I have decided to give my book away for free on the internet; I also decided to proofread it again and put the “i” in SMARiTT throughout the rest of the book. I should have given it away alot sooner, but that is another publishment that I will write about soon. Plus, since the SMARiTT people are still stealing my mail at the US Post Office (15 years now), preventing me from selling it to acquire more resources and funds to do more about it, it is a “good” idea. The important thing is that SMARiTT comes out publicly so that we may all access it for the safety and security of ourselves, our families, our loved ones, our country, and the world.)

Opening

Since August of 1996 I've written and sent many letters to the press, government officials, and other people, pertaining to SMARiTT. I've referred to it and called it several other things, such as; Stealth Monitoring Technology (SMT), Stealth Monitoring (audio & video) Inner Telecommunications Technology, Stealth Monitoring and Broadcast Technology, or even Stealth Technology (ST) for short. While I was writing this report I came up with a few other names to call it. One of them was SMATT which means Stealth Monitoring and Telecommunications Technology. I settled on SMARTT which means, Stealth Monitoring and Recording Telecommunications Technology. I'm calling it this because I wanted the name to be as specific as possible and still be simple. I also wanted the name to be as accurate as possible to label what it is, what it does, and what it is used for. Since it didn't officially have a name, I gave it one. Irregardless of what you call it, it's still the same thing.

SMARiTT is a national and international monitoring system and it has been permanently installed nationally and internationally for several scores. It's financed with taxpayer's dollars and it goes under the label of national security equipment. It consists of high tech electronic monitoring equipment, used to monitor everything. It's continually upgraded at taxpayer's expense. The scientists and people who work on it or with it are all under high level government contracts. SMARiTT is used by large companies, small companies, government agencies, the military, the local, state, and federal police, the intelligence communities, and many other people. There are many government agencies set up to monitor everything. They monitor everything from the weather, to people, to even monitoring for extra terrestrial activity. This report is mainly about the SMARiTT system that is set up as a national security system and is used to monitor and remote control society, reality, and humanity. It's a system of microcameras, microphones, satellites, eeewaves, computers, and a whole lot more. It's used to monitor the entire American population. It is strategically placed and installed outside, inside everyone's home, in all buildings, cars, buses, vehicles, airplanes, and a whole lot more. It is used to monitor every single person's life and existence, consistently, 24 hours a day, 7 days a week, 365 days a year. It not only constantly monitors everyone, but it also constantly records everything. SMARiTT is operated, managed, maintained, controlled and remote controlled by people in a government capacity or similar, the family/company way, with the most sophisticated computers in the world. These computers are programmed to be user friendly at taxpayer's expense. Computers not only manage and control the equipment, but mostly everything is recorded and stored in computer microchips. The sophistication and innovation of technology enables people to monitor and watch other people in a stealth fashion. This means everybody is monitored, 24 hours a day, 7 days a week, 365 days a year, no matter where they are at, but the people being monitored can't see the equipment being used to do so, nor are they allowed to know it exists or that it is really being used that way. This book/report is written to prove beyond a shadow of a doubt that it is real and that it is paid for with taxpayer's

dollars and belongs to the American people for national security and the security of ourselves and our families. This report is based solely on fact.

Monitoring Technology

(The commercial market and security systems.)

Monitoring technology on the commercial market is and has been a part of the security industry for a long time. The telephone was the first monitoring device used for a security system back in 1877. Technology has come a long way since then. Today monitoring technology is used by millions of companies for security. Here is a small list of places that use cameras and monitoring technology for security or whatever.

In most of these places the cameras are visibly seen or hidden behind obvious mirrors. The audio is not really ever seen, but it is there for the people who spent the extra money for it. In the security industry, audio was first. Monitoring technology can be purchased from security companies and other places. Monitoring technology can also be purchased from spy tech shops. You can even make your own with camcorders, small tape-recorders, AM or FM radio microphones, hearing aids, intercom systems, or whatever.

On the commercial market, if you have enough money, you can buy some very sophisticated monitoring equipment for security, but what is on the commercial market is only what has been declassified by management. Which means, it is only what certain government officials, those who oversee science and technology, have decided is okay for the public to know about or to be marketed on a public market. This means the sophistication of SMARiTT is a lot higher than the American people are allowed to know about and it is controlled by a small group of people in a government capacity who get to keep it for themselves and decide what they want to let the American people know about.

When the cameras are seen, it is monitoring technology. When the cameras are not seen, it is stealth monitoring technology. As I have said, audio is not ever really seen, but it is there. Therefore, audio is always stealth monitoring technology. Audio was also first and easiest to install. Recording systems are used to record that which is being monitored for the obvious reasons. Computers are generally used to operate, control, and manage this

stuff. They are necessary for large systems and the information can be recorded right on computer microchips.

SMARiTT

(Stealth Monitoring And Recording inner Telecommunications Technology.)

Stealth means- invisible to human detection, clandestine, or to steal. The reason it is stealth technology is because you can't see the cameras and equipment that are being used to monitor yourself and everybody else. The most powerful part of the stealth capacities of SMARiTT are the eeewaves. Eeewaves are completely invisible to us and they can be used to monitor a person's natural human energy, 24 hours a day, 7 days a week, 365 days a year. Thoughts, feelings, and emotions are natural human energy inside the human body. Eeewaves can also be used for human radar. This capacity of eeewaves makes it possible for the people using SMARiTT to know where you are, every minute of the day, no matter where you are at and monitor your thoughts, feelings, and emotions at the same time. Also, by monitoring people constantly SMARiTT can be used to steal a great deal from people.

Monitoring means- to watch, observe, regulate, supervise, oversee, or to control. The monitoring capacities of SMARiTT are constant, steady, continuous, unchanging, and unyielding. SMARiTT is electronic equipment, therefore, for as long as the electricity is on, SMARiTT remains on. The computers that regulate SMARiTT are programmed to keep it constant, therefore it will always be watching you. But remember, computers and electronic equipment can't really watch you, only the **people** using it can watch you.

Recording means- SMARiTT records everything that it monitors and since everything is being monitored, everything is recorded. These recordings are made and kept with computers right on computer microchips. Audio, video, and eeewave recordings of natural human energy are all stored in computers. These recordings are accessible by the people who have access to these computers. The recording capacities of SMARiTT are a very powerful part of SMARiTT, because it enables the viewer to monitor people out of time and it also creates and maintains the feeling of being watched constantly inside the person being monitored. Since SMARiTT is electronic and it constantly monitors and records everything, it can simultaneously maintain the feeling of being watch in every single person. Plus, the recording capacities of SMARiTT enable the people who have access to it the ability to research and monitor a person's past.

Inner means- the ability to monitor, listen to, and record a person's thoughts, feelings, and emotions from the inside of them with radio eeewaves.

Telecommunications means- the ability to communicate with someone using electronic equipment. With the eeewave capacities of SMARiTT, not only is it possible to monitor and record thoughts, feelings, and emotions, but by transmitting on that frequency and, or wavelength, it is possible to communicate with the person being monitored. Since the eeewave capacities of SMARiTT connect directly with a person's natural human energy, the person being monitored doesn't need any electronic equipment to receive the transmitted

communications. Since this aspect of eewaves is not known or understood by most people, it gives the people using it the ability to communicate with people in a stealth fashion, anytime of the day or night, without the permission of the person being monitored. It also gives the people using it the power to violate a person's time, privacy, serenity, peace of mind, thoughts, feelings, emotions, soul, and a whole lot more.

Technology in this aspect, simply labels all of the equipment used to monitor, record, and telecommunicate everything in a stealth fashion.

A Short History of Technology.

Electricity was harnessed in the 1800's. Electricity had been theorized for thousands of years. It was studied for centuries before Alessandro Volta invented the first battery in 1800. The battery was called Voltaic piles.

In 1826, the first photograph was taken. This was the beginning of photography and pictures.

In 1831, the electric generator was invented. Electric generators could produce direct current (DC) or alternating current (AC).

In 1837, the telegraph was invented. The telegraph was the first communication device used to send messages, through wire, with electricity. Before the telegraph, the mail was the only way to send messages over a long distance. The telegraph could send messages, over long distances, through wire, and it would be there instantly. The mail could take days, weeks, or even months before it got there. The telegraph was used for over forty years before the telephone was invented.

In 1876, the telephone was invented by Alexander Graham Bell. It was the first communication device to transmit voice through electrical wire.

In 1877, the phonograph was invented by Thomas Edison. The phonograph was one of the first inventions to record sound. The phonograph recorded the sound on tin foil using vibrations. The ability to record sound electronically, magnetically on metal wire did come about in the late 1800's, but the phonograph was a lot more popular at the time.

In 1894, the moving picture was invented by Thomas Edison. It was called the Kinetoscope. This started the beginning of video recording. The recordings were made on film.

In 1895, radio was invented. It was the first communication device to send the electronic signals through the atmosphere using eewaves instead of sending the signals through the wire.

In around the 1920's television was achieved. Television had been researched for several decades prior. Some of the first attempts at television took place in the late 1890's. A scanning device was used to attempt to send pictures from one place to another. The electronic signal was sent through the wire.

In the 1930's German scientists invented a way to record sound electronically on a plastic tape coated with a certain type of metal that could be magnetized easily. This is where tape recording began. Before tape

recording, sound was recorded electronically on metal wire.

In the 1930's computers started to mature.

Radar (radio detecting and ranging) was being researched and developed through the early 1900's. Radar is the ability to see, find, track, and range objects using eewaves.

In 1957, a Russian scientist put the first satellite, in an orbit, in outer space. This started off the reality of space travel, aerial recognizance, and communications relays.

The purpose of this short history is to enlighten you to how long this stuff has been around. Technology is over a hundred years old. Thousands of inventions were developed from the harnessing of electricity back in the 1800's. We have millions of them now. I only listed here a small few of them, that are directly used for stealth technology.

A Short History of the Economy, Business, and Technology.

Back in the 1800's the economy was very slow compared to what it is today. There was no such thing as national marketing. Transportation was also pretty slow. Steam engined trains existed, but the horse and stagecoach were still the main mode of transportation, next to walking. Most people had to hunt, gather, and,or prepare their own food. They didn't have refrigerators or freezer to preserve it. Most of the businesses that did exist, usually sold their products or services to the town they lived in. There was no such thing as mass production either. A good black smith could produce about six accurate rifles a year, making them by hand. The post office was set up by the government back then and the fastest way to send mail was by pony express. Otherwise it went by train or stagecoach. Education back in those days went kind of slow too. If you wanted an education you had to go out and get one on your own. Most people back in those days built their own houses. Log cabins, with dirt floors, were pretty popular. You could barter for an ax or make one of your own, go cut down some trees, and build one yourself. Back in those days, if you made a thousand dollars a year, you were considered very well off.

During the later part of the 1800's, inventions started to grow rapidly, but the economy was still pretty slow. When Alexander Graham Bell invented the telephone, it didn't go on a national market over night. It's uses and availability went kind of slow. It took years to establish a large network of phones for communications, especially long distance communications.

One of the first uses of the phone was, as a security system. In 1877, a man installed phones in four banks and a factory. They were operated with the first switchboard. At night the phones were used as a burglar alarm. The phones were kept on in the buildings and the person monitoring the switchboard could hear whatever was going on in them. So, if a burglar were to enter, the person

monitoring the phones could hear them. In essence, the phone was the first eavesdropping device.

In 1897, one of the first movie projectors was invented. The word movie is a shortened version of the words moving picture. This kicked off a new industry. In the early 1900's theaters were put up and silent films were shown to public audiences. The technology to add sound started to grow. Cutting and splicing film became an art. Camera technology became a science. Audiences began to grow. Scientists and inventors played a major role in a lot of this stuff.

A couple of major points I would like to make about video technology, even back in those days. One, the moving picture is a video recording on film, thus the original capacity of video was, as a recording. Two, scientists not only worked on a lot of this stuff, but cameras were used for scientific research and studies. Using the camera to record things on film, and then studying the film later, gave scientists a new way to view things. The camera allowed people to see things they couldn't have seen before with the human eyes. It could also be viewed over and over again.

Up until about the early 1920's most things were made or produced by hand. When Henry Ford developed the assembly line, he kicked off mass production. This era in history has been called industrial revolution. I prefer to call it industrial modification. The ability to mass produce products enabled people to increase just about everything about business and the economy. Mass production created, mass profits, mass tax revenue for the government, mass marketing, more jobs, and so on. It also kicked off the stock market and a new type of economy. With this innovation also came the arms race and a whole lot more.

Government controls over technology grew stronger in the thirties and forties. Certain government officials had been in on the research and development of technology from the beginning. Electricity and inventions were thought to be power. World War One took place from 1914 to 1918. Technology was used then. During World War Two, technology and mass production had a major role in the war effort. World War Two took place from 1939 to 1945. During this time a lot of things happened in the government. A lot of new agencies had been set up to gather intelligence for warfare. Technology was used to acquire intelligence. Espionage became a science. Many countries used technology for warfare. Small electronic bugging devices were used for espionage by most of the industrialized countries. Audio devices were commonly used because they could be produced small enough to hide in places so that they couldn't be found easily. Telephones were still one of the easiest ways to bug a room. The research and development of all kinds of inventions, technology, weaponry, sciences, and medicine went through the roof. All of it was financed with taxpayer's dollars and was done under high level government control. The management of people, also became a science. It was the start of organized paper records to record people's histories. Serial numbers were issued to soldiers so that we could keep track of them. Serial numbers later became social security numbers for the management of the American people.

Computers started to become more and more sophisticated. Computers

were used for many things in World War Two. They were used to control weaponry and other sophisticated electronic devices. They were also used to store massive amounts of information, plus a whole lot more.

Television, which means to extend or project one's vision, became publicly known, in America, in 1939 at a world's fair. In 1940 it went on the public market. It had been around for at least twenty years minimum before the public knew about it. It was worked on and produced under government security and not released to the press until 1939. It went on the public market in 1940, but it was too expensive for most people to be able to afford one. It wasn't until the late 1950's that the majority of American citizens had one. The television and movie industry was booming at this time. They had a national market and was making mass revenue. They were then and still are now, one of the nation's and the world's foremost leaders in the research and development of high technology. Technology that has to do with electronics, cameras, audio equipment, sound, communications, video, computers, film, sciences, and so on, and so on.

In 1957, a Russian scientist put the first satellite in orbit. The satellite was called Sputnik. Sputnik was equipped with a radio beacon that radioed a signal back to earth to prove that it was really up there. Before this, attempts were made to put satellites in outer space, but it wasn't until it was discovered that it had to be put into an orbit in order for it to stay in outer space. This is what kicked off the space race. The space race was about the same thing as the arms race at that time. The first uses and still the major uses of satellites are for communications relays and aerial reconnaissance. Most communications satellites are put into an orbit at twenty-six thousand miles over the equator, above the earth. These satellites are in an orbit, rotating at the same speed and in the same direction as the earth. By doing this, the satellites stay over the same area of the earth at all times.

Reconnaissance satellites are satellites that take photographs of the earth or whatever, from outer space. Realistically speaking, if you have a telescope that can see other planets clearly, you can use it for a lens to take pictures with. In the beginning, reconnaissance satellites sent pictures back to earth in two ways. One, satellites were sent up to take pictures on film, then the satellites had to be brought down and recovered to develop the pictures and study them. Two, pictures were sent back by radio waves and viewed on a television monitor. At that time it was considered safer and better to take pictures on film instead of radioing them back, because the pictures on film were clearer and it was thought that the radio transmissions could be intercepted by other countries. During the 1960's it was a satellite photo that showed that Cuba was building a missile silo during what was called the "Cuban missile crisis". As technology grew, it was more expedient to radio the pictures back, because it was a lot faster, the quality of the pictures got a lot better, and they learned how to scramble the signals. All these pictures are and were totally recorded. They would have to be, in order to study them later and to insure that nothing was missed. Reconnaissance satellites are put into orbit over the equator also. By putting them over the equator, they can monitor the same area of the earth constantly, but in order to monitor areas not under the

equator, it is necessary to put at least three to four satellites in the same orbit to monitor the area under their path, 24 hours a day, 7 days a week, 365 days a year. For the purposes of national security, there are more than enough satellites in orbit, over the earth, to monitor every square inch of it, 24 hours a day, 7 days a week, 365 days a year. All these satellites are financed with American taxpayer's dollars and are for the security of the American people.

Some Theory, Philosophy, and Reality Behind National Security and SMARiTT.

Radar is the ability to see, find, detect, and track things using eeewaves. Radar was developed back in the early 1900's. When it came about, certain government and military officials determined it was necessary to install nationally for the purposes of national security and to be militarily ready in case of war. They spent millions of taxpayer's dollars to install it nationally. Back in those days a million dollars was a very large some of money. By the time they had it, almost completely installed, it was surpassed and outdated. That rendered it useless and all the money they spent on it was out the window.

When it comes to SMARiTT, the same way of thinking applied. For the purposes of national security, SMARiTT was installed nationally and used internationally for espionage, intelligence, and so on. The biggest changes took place during WW2. A lot of scientists worked on technology for the war effort. A lot of the focus went into espionage equipment and technology. Producing them smaller and smaller was also a part of the focus. Mass production was the standard by this time. Small electronic bugging devices were common and used by many countries. Cameras were produced smaller so they could be hidden a lot easier. Small cameras were used to take pictures of documents. The telephone was still the easiest way to bug a room. All of this stuff was recorded also. Recording it was necessary for the obvious reasons. Such as; One, so the person monitor it didn't miss anything. Two, so there would be proof and evidence if needed. Three, so it could be studied later. Four, so the person doing the monitoring could call their boss and show him or her. Five, and so on, and so on.

Technology was not only used abroad to gather intelligence, but it was used here to monitor the scientists and the people whom worked on this stuff, to insure there were no spies. This is called counter intelligence. Even back in those days, they built buildings with electronic bugging devices built right in them. This is what is known as a security building.

Some Technology Directly Related to SMARiTT.

The term technology means the science of technical things. Technology generally labels electronic equipment, machinery, and a lot of other things that have to do with industry.

Mass Production

Mass production is the ability to produce products at a very high rate of speed. This is done by using machinery and developing systems and methods to increase the production of just about everything. Mass production became a technology back in the 1920's when Henry Ford developed an assembly line to mass produce the automobile. This means the technology of mass production has been researched and developed for over seventy years now. Mass production is a major focus in business and industry today.

Miniaturization

Miniaturization is the ability to produce things smaller and smaller. Miniaturization has been a major focus in technology for at least, since, World War Two. Scientists and inventors worked on the technology to produce eavesdropping and espionage equipment smaller and smaller so it could be hidden a lot easier. Electronic microphones, at that time, were small enough to hide in places without being easily found. Small cameras were developed to take pictures of documents.

Today the technology of miniaturization is more highly sophisticated than the American people are educated too or are allowed to know about. Doctors today can perform surgery on human body parts thinner than a human hair. This is done by performing the surgery under a microscope. Cameras and audio equipment can also be built under a microscope. Audio equipment is quite easy to produce and hide. Back in the 1970's I saw in the press that microphones as small as the tip of a pencil were sophisticated enough to hear everything very clearly, up to two blocks away. Cameras can also be constructed under a microscope. This means that the cameras are microscopic and that's why people can't see them with their eyes.

When it comes to technology a lot of time goes into producing a prototype or the original perfected model. After that the focus goes into producing machinery to mass produce it. When the machinery is perfected to mass produce it, the product can be mass produced by the thousands or even millions. One of the great things about producing microscopic equipment is that the product requires very little materials, which means that the cost is extremely inexpensive, pennies a unit.

Now, when it comes to any kind of electronic equipment, even microscopic equipment, you have to have a power source. The power source for this type of equipment is obviously a battery. Yes, batteries can also be produced that small. A five year lithium battery would work, unless they have

perfected something better than that by now.

There is one other point I would like to make about microscopic eavesdrop and monitoring equipment. The fact that they are so small, cost so little, and last about five years or more, makes them disposable cameras and microphones. When the battery goes dead you don't replace the battery, you just install a new unit. Besides that, it would be a little hard to find the old one anyway.

The Electronic Signals

The electronic signals are what connect all of the cameras, audio equipment, and so on. There are only two ways to send and, or receive electronic signals. One is through the wire and the other is through the atmosphere using eewaves. These two ways are commonly used together. Computers centrally control and manage all of this stuff. When it comes to sending signals through the wire, there are at least two major, national, public wire systems. One of them is the electric company and the other is the phone company. The cable television company is another example of a national wire system. Computers can send and, or receive signals through any one of these wire systems and it can be done extremely sophisticatedly. Also, other wire systems have been or can be installed for even higher security purposes. When it comes to sending the signals through the atmosphere, this is done through eewaves.

Electronic Electromagnetic Energy Waves (eewaves [e-waves])

Electronic electromagnetic energy waves have been called many things. They have been called radio waves, airwaves, electromagnetic waves, or maybe something else. Eewaves are simply electronic electromagnetic energy waves transmitted and, or received through the atmosphere with electronic equipment. Eewaves are completely invisible and they are commonly used everyday. Eewaves are used in a vast array of uses. The eewave range, scope, or field is enormous and probably infinite. Here is a list of some common, everyday uses of eewaves.

Eeewaves have many different frequencies and, or wavelengths. Irregardless of what frequency or wavelength, they can transmit and, or receive electronic signals nationally and internationally through a system of relays and through the wire. Eeewaves are not only used to receive the pictures taken by the television cameras on satellites, but they are also used to remote control the cameras in the satellites as well as remote controlling the satellite itself. Satellites are also used to relay communications throughout the world using eeewaves.

Using eeewaves to carry the signals and to connect and remote control all of the electronic surveillance equipment is the easy stuff. Using eeewaves to monitor the natural human energy inside the human body is not really known or understood by most people. Thoughts, feelings, and emotions are natural human energy inside the human body and they can be monitored and recorded just like anything else.

Electricity comes from two different sources. One of the sources is from a chemical reaction with two different types of metal. This is how the original battery was discovered and what all batteries are made of. If you take a lemon from the grocery store and squeeze it thoroughly without breaking the peel, then stick one thin piece of copper and one thin piece of zinc through the peel, the acid in the lemon will react with the metals and create electricity the same as a battery. The other way to produce electricity is through a generator. A generator produces electricity by rotating a coil of wire through a magnetic field produced by natural magnets. A battery produces direct current (DC) electricity and a generator can produce direct current (DC) or alternating current (AC) electricity.

There is electricity in the human body. The electricity in the human body comes from the chemicals secreted in the body reacting with the metals in the body. The fuel for these chemicals, to be constantly produced, is food and water. The electricity in the body is why we maintain a body temperature of about ninety-eight degrees Fahrenheit. When we have a pain in our leg or something, the nerve endings in that part of the body send a message to our brains, letting us know there is something wrong in that part of our body. These messages are sent through the natural electrical energy of the body.

Thoughts, feelings, and emotions are natural electrical energy in the human body. Einstein said, "All things are made up of energy". Using the natural energy in the human body has sometimes been referred to as being "hard". People can get hard in different ways. A person uses their energy differently for different activities, conditions, or circumstances. For example, one would be hard in one way to play baseball, and in another to drive their car home. One would use their energy for swimming, differently then, from using their energy to play chess. No matter what a person is doing, whether it is washing the dishes, working on their car, walking down the street, or just sitting around the house, they are using some kind of energy from within themselves. Feelings like depression, joy, happiness, being tired, being up and ready to go, or just about anything else, is a part of a person's energy.

A person can use their energy for communicating things also. Most of the

time when a person is talking to someone they are also watching their energy. People naturally watch other people's energy, even without thinking about it sometimes, to see how the other person feels about whatever they are talking about or to see if they are telling the truth or whatever. People who have jobs as interpreters are trained to take note of how a person is expressing themselves using their energy. A person's energy can also be viewed very extensively on SMARiTT. A person can generally see another person's energy on television, in the picture. Especially stealth television, when the person being watched is not in any kind of character like an actor or an actress. It can also be heard in the sound of their voices.

Eewaves are produced from the harnessing and controlling of electricity with electronic equipment. Eewaves can be transmitted from one place and received at another or many places using electronic equipment. Eewaves can also be used as carrier waves to receive signals at a source or to carry the signals of another frequency or wavelength.

Natural electromagnetic energy waves exist. One example of natural electromagnetic energy waves are the magnetic forces of the Earth's North and South Poles. This energy is what makes a compass work and theoretically it is the earth's electromagnetic energy that magnetizes natural magnets.

People have the ability to transmit or project natural electromagnetic energy waves using their natural electrical energy. For example, just about everybody has connected with someone from across a crowded room. You were just standing there and you felt something, like as if someone were staring at you. When you turned to look someone was and you made eye contact. It is a natural instinct or sensory perception to feel it when you are being watched. The person staring at you was projecting or transmitting their energy and you received it. When you turned to look, someone was really there looking at you and you made a connection of human energy.

Receiving someone else's energy is the same thing as receiving that person's natural electromagnetic energy wave. Even if a person is using their energy wrong, it is still communicated through natural energy waves or seen with the eyes and one's own energy. Not only do humans have the ability to communicate using their energy, but all other animals communicate using their energy. In fact, humans understand it and use it the least, because most people are taught to use speech and, or words to communicate, rather than using or understanding their own energy or the energy of others.

Eewaves can simulate natural human energy waves the same way a sun lamp simulates the natural light of the sun. Using eewaves on the same frequency or wavelength as natural human energy enables the person or people using the electronic equipment to monitor a person's natural human energy. In this way, the person or people using eewaves to monitor another person's energy can listen to their thoughts and electronically reproduce, monitor, and gauge their feelings and emotions. With eewaves and the electronic equipment over natural human energy and natural human electromagnetic energy, the natural human energy and the natural human electromagnetic energy can be monitored, manipulated, amplified, redirected, interrupted, violated, recorded,

rebroadcast, and so on, and so on.

Eewaves connect directly with a person's natural human energy. For this reason, the person being monitored doesn't have to have or need any electronic equipment to be connected to the electronic monitoring equipment. The signals go back and forth through the eewaves. Artistically speaking, every person has this energy and eewaves can connect to everyone all at the same time. Imagine all of the people as walking antennas. In this fashion, eewaves can also be used for human radar. Computers operate, manage, maintain, and control all of this stuff. There are computers specifically programmed to do this and they also record everything on computer microchip.

Eewaves can simulate natural human energy waves the same way a sun lamp simulates the natural light of the sun. Just as a plant doesn't know a sun lamp is not the sun, a person feeling energy transmitted into their own energy via eewaves can feel that energy just as if it were their own. In fact, it really could be their own energy recorded and rebroadcast back inside their energy. This can be a very powerful way to manipulate someone. Because eewaves can be used to monitor and receive a person's natural energy, the person monitoring another person can listen to whatever that person is thinking. They can also feel their feelings as those feelings are in the form of energy inside the human body and can be monitored, received, and rebroadcast using eewaves and electronic equipment. Thoughts, feelings, emotions, and everything else that goes on inside the human body can be monitored and recorded. Recording a person's energy is a very powerful thing. This recording can be retransmitted right back into a person. The retransmission can be electronically manipulated, amplified, played in a loop, or maybe something else. Playing something in a loop means to take a recording, lets say a three second recording, and put it end to end so that the recording plays constantly, without any breaks. Rebroadcasting the recorded energy of someone back into that person using eewaves, can play tricks on people's minds, prevent them from growing properly, emotionally, spiritually, or whatever, and can create what I call time warps. Time warps are when a person has a feeling out of time or when a person is locked into or can't get over a feeling they should have, of their own free will, in what would be considered due time. Retransmitting someone's recorded energy back into them can also cause them to have involuntary feelings at the wrong time or cause them to recall memories while they are thinking about something else. Time warps may have other capacities also.

When it comes to a person's emotions being recorded, people have all kinds of emotions. Fear, pain, happiness, and joy are all emotions. If they are recorded and played back into you, they would most likely cause you to recall or have reoccurring thoughts, feelings, and/or memories.

Eewaves are the major aspect of the telecommunications in SMARiTT. The people using SMARiTT to monitor people can listen to those people thinking and can feel their feelings. They know everything there is to know about that person including their inner most thoughts and dreams, what they fear, what they want out of life, and anything and everything else. Since the telecommunication aspects of eewaves go both ways, they can not only

monitor the person, but they can communicate with them. This means they can talk to them and use their energy to communicate to them anything they want. The people using the electronic equipment can communicate whatever they want to the person being monitored, without the person being monitored having anyway to do anything about it. Especially since SMARiTT doesn't officially exist yet and since eewaves are completely invisible and they can connect directly with a person's energy, the person being monitored doesn't need to have any electronic equipment to be connected and communicating with the person or people monitoring them using electronic equipment. This usually does play tricks on the people being monitored because they are communicating with people who aren't physically there. This creates what I call an automatic natural doubt as to whether or not the communications are real. It also violates natural sensory perception, because the person being monitored can feel themselves being watched, plus they can hear the voices of the people monitoring them, and it also affects their feelings and emotions from the inside, but there isn't anyone actually, physically present. It's all done across SMARiTT.

Natural human energy inside a person can be stronger than the recordings of their own energy or of another human transmitting their energy into you, but the use of electronic equipment is very powerful and more constant. For example, when a person is out doing something they are what would be considered up. Their energy would be focused on what they are doing. When a person is up, doing something, it is harder for the people using SMARiTT to penetrate their energy with technology. The awareness and attention span of the person being monitored is more concentrated and focused on what they are doing and less drawn in and focused on the communications broadcast into their energy. However, when that person is less active, at rest, at peace with themselves, or not really doing anything, they become more vulnerable and susceptible to the effects of SMARiTT and whatever the people using it are transmitting in. It is natural and normal for people to get tired. In reality, it is why we all have to sleep. SMARiTT doesn't get tired. It's electronic and for as long as the electricity is on, it remains constant. When a person is more at rest, their attention span and awareness is more opened. This is when the people using SMARiTT have the greatest power to penetrate their energy. The person being monitored can be drawn in and their attention span becomes focused on the communications that are being transmitted into their energy or the person being monitored may become more aware of the electronic manipulations of their energy with eewaves and may try to or have to combat them. This can cause a person to become drawn in to a point where they are less coherent as to what is going on around them. This can also cause a person a whole bunch of other problems having to deal with the affects of SMARiTT and how it is or can be used. SMARiTT and the people who use it this way are responsible for at least ninety-five percent of the emotional, mental, and psychological ailments in society and reality today. A person can even be hypnotized across SMARiTT without their permission and hardly no way to defend themselves against it.

With the video alone, it is possible to connect with someone in the

picture, using natural human energy. This can be done on what I call real time, which means the person viewing someone on the monitor is looking directly at the person being monitored at the same (current, concurrent) time, or it can be done in a video recording. If a connection of natural energy between the person doing the monitoring and the person being monitored happens in the recording, the person being monitored is feeling the connection out of time. Also, the person being monitored is subjected to this connection against their own free will and with no way to prevent it from happening.

With audio alone, it is possible to connect with someone using natural energy. Everybody has connected with someone over the phone before. Might I be so bold as to say that, that is what the phone sex industry is all about. With stealth audio equipment, the person doing the monitoring can connect with the person being monitored without the person being monitored having anyway to prevent the person who is doing the monitoring from doing so. The person being monitored would be able to sense this connection of natural energy, but would have a very hard time trying to connect back with the person doing the monitoring. Especially if the person doing the monitoring has training or knows how to be that quiet and disacknowledges his or her presents on the other side of the eavesdrop equipment. Also, the person being monitored would not know who is doing the monitoring.

Audio and video together are a part of the telecommunications aspects of SMARiTT, but eewaves are the most powerful part of SMARiTT. Eewaves are used to monitor what goes on in the inside of a person. They can also be used to connect with a person, from the inside. All three of these things together are what is used to monitor and remote control reality and society, 24 hours a day, 7 days a week, 365 days a year. Plus, everything is recorded and stored in some of the most sophisticated computers in the world.

This capacity of eewave technology is little known by most people. It is not sold on the commercial market. It is held under high level government security and has never really been released to the press to this capacity. The only people who have access to this type of equipment are management and the people they brought in or let in the family way.

(Note: There are thousands of government employees employed to keep up and maintain SMARiTT and the electrical power that keeps it on. SMARiTT does not get tired. It is maintained around the clock and they have many back up systems just in case. These people also get paid with taxpayer's dollars and are serving management, under contract, for the purposes of national security.)

Computers

Computers remote control and manage all of the electronic equipment. There are computers in the United States of America that are bigger than alot of people's houses. These computers were financed with American taxpayer's dollars and are for the purposes of national security. The reason why they are so big is because they have more memory than any other computers and they are programmed with more programs than any other computers, and so on, and

so on. The computer programs are written by thousands of computer programmers, who are all under contract to serve the United State government. Computer programs can also be contracted out to American businesses that are in the business of writing programs for computers. Management can have any kind of computer programs they want written. All these programs are written by people under contract to serve their country or contracted out to companies to serve their country, all at taxpayer's expense. They have more computer programs then anyone else in the world and they are the only people with security clearances high enough to use these programs or the computers.

The most sophisticated computers in the world can perform millions or billions of functions in less than one second. All computers can be hooked up or linked to each other through a wire system or through eeewaves or through a combination of the two. All computers can be centrally controlled in this fashion.

Computers can store and recall infinite amounts of information. Computers can digitally record and store audio, video, and natural human energy using eeewaves on microchips. With mass production, not only is it possible to produce enough microchips to record and store everybody's life, 24 hours a day, 7 days a week, 365 days a year, for their entire lifetime, but it is the science of technology. All of these computer microchips are financed with free government money (taxpayer's dollar) and as they say in the electronics industry, the upgrades go very well. Management as the federal government are always the first people to get the upgrades and they get to determine if they want to keep them to themselves or if it is okay for other people to know about them and,or if it is okay to sell on the commercial market.

Computers can be programmed to control, remote control, manage, and,or operate just about anything that has to do with electronics or electrical equipment. Another thing they say in the computer industry is that it's all in the software. The sophistication of computer technology, integrated with audio, video, and eeewave technology, is highly advanced. Alot of this stuff can be seen on the commercial market, but the most sophisticated stuff is held under very tight security by management. When it comes to playing a recording in a loop, it is simply a simple computer command. The computer is programmed to do so. When it comes to electronically manipulating the energy, it is also simply a simple computer function. Computers are generally programmed to be user friendly. This makes it easy for anyone to be able to operate them, once you've learned how.

There is one more major point that I would like to make about computers and all the rest of the electronic equipment. The computers and all of the rest of the electronic equipment cannot operate all by themselves. They have to be and can only be operated by people.

Some Sciences Directly Related To, Developed By or Redeveloped By Using SMARiTT.

The suffix "ology" at the end of a word means it is a science, or has been studied as a science. A word or a subject doesn't necessarily have to have the suffix "ology" to be a science or to be studied as a science. The science of science is the science of how to study, research, and develop anything in a scientific manor. Studying anything in a scientific manor means to tear it apart, break it down, research it, develop it, learn everything there is to know about it, and record the data by writing it down or putting it in a computer. Just about anything or everything you could think of or want to know about can be studied as a science.

The word technology was originated back in the earlier part of this century to label the science of making the machinery for mass production. It means the science of technical things. The technology of SMARiTT is covered in another section of this book.

Sociology

Sociology is the science of studying people and human social behavior. In grade school it was called social studies. On the adult level, with SMARiTT, it is a very intense and in depth science. People have been studied with SMARiTT for about a hundred years. It started with using the telephone to monitor people in their homes and businesses in the late 1800's. Then the camera was used in a stealth fashion to record people's lives on film in the early 1900's. Then television was perfected and used in a stealth fashion to monitor and record people's lives in around the 1920's. Eewaves were developed and used to monitor natural human energy in what I would guestimate at about the early 1900's. Since at least the 1940's, stealth technology has been permanently installed as a national security system to monitor everybody and everything. As it was being installed, it was installed where management wanted it or needed it the most, first. Then it branched out accordingly. As technology became more advanced, it became easier and easier to install everywhere. All of this means that people have been studying other people with stealth technology for over a century and sociology as a science has been researched, developed, and redeveloped with SMARiTT for several generations.

Now imagine spending all of your time watching real people, in their real lives, using SMARiTT. You would be able to see how they react to or handle every or any situation they are in, all throughout the day, consistently, non stop, without any breaks. You would be able to see what they do and what they go through. You would be able to listen to them think and gauge their natural human energy and feelings. After watching people for so long, you could pretty much predict what they are going to do or how they are going to react to whatever situation they are in or come into contact with. You would learn their natural habits, their normal routines, how they think, what kind of attitude they have, which way they drive home from work, what they fear, what kind of sex

life they have, and just about everything and anything else there is to know about that person or any person.

Since SMARiTT is full time and permanently installed nationally and internationally, you could view any one person or groups of people, all day long, wherever they go. Not only could you view them in real time, but you could view them in the recording also. The recording enables the viewer to be able to see what anyone is doing, anytime of the day, anywhere they are at, without actually watching them directly, at that time. The viewer can simply monitor the recording. This is again, part of what I call the time warp factor. Because it is a natural human instinct to feel it when you are being watched, being watched out of time, in the recording, creates confusion inside the mind and soul. Being watch with SMARiTT period, creates confusion in the mind and soul. Whether or not it's real time or the recording, your natural instincts let you know you are being watched, but your normal sensory perception does not detect anyone there and you can't see who is watching you. This gives the people using SMARiTT certain power to play tricks with people's minds, souls, serenity, instincts, emotions, feelings, and whatever else goes on inside a person.

Psychology

Psychology is the science of studying the human mind and soul. On the medical side of psychology it is supposedly used to help people with mental, psychological, or emotional ailments. However, since most of the ailments are directly caused by SMARiTT and the people who use it that way, psychology is mostly used to keep people down and prevent them from having real lives. Most of the people in the professional, medical field of psychology were taken in the family way and have contracts stating they are not allowed to tell anyone about SMARiTT. For this reason, these professionals have to willfully lie to people to keep them in their ailments and prevent them from healing. The truth is the number one element in healing and yet people are lied to and prevented from having a normal life because the people using SMARiTT want it that way. Using SMARiTT to induce these types of ailments discredits people from having real jobs and real lives. Also, the medical industry of psychology is a lucrative one. Psychologists on a low end scale get two-hundred dollars an hour (or per person) and there is alot of federal funding, funneled through this industry.

Psychology in business today is used in many ways. Psychology is a standard, modern business practice. It is used to control or manage employees. It is used to have an edge in business deals, but if you really want to have an edge in business deals, you have to have access to SMARiTT. It is used to get people to sign contracts and a whole lot more.

Psychology is also used in the government today and in all government agencies. Psychology is taught to most government employees. It is more like teaching them how to lie and communicate it with their energy like an actor or an actress. If you want or need something from them, like to do their jobs properly, and you know the family way and go along with it, you just communicate it with your energy like you know and they may help you. When

going along with the family way, sometimes you know it is wrong and that they do it, but you have to go along with it like it is right and they have a good reason. If you don't go along with the family way or if it goes against what they want or against them personally, they will automatically keep you out and give you the routine. The routine is to give you the run around, make it take longer then it has to, and a whole lot more. If you are asking a question about something you need to know about or are entitled to know, the first automatic psychological response is "Why do you want to know that". The reason they ask you this is to interrupt your energy and progress and to put the question back to you. They also have this thing about you have to be nice and do it right. So, when they ask you, "why do you want to know that", if you don't tell them, they can do you like you are not doing it right. If you do tell them, they can decide whether or not they want to tell you. If they think it is okay for you to know, they may tell you like a friend, taking you in the family way. If they decide it is not okay for them to tell you, they may put you off, send you to another office, give you the run around, or use their energy to communicate to you that they don't have to help you. They may also use their energy to antagonize or provoke you into becoming pissed off so they can say you didn't do it right. If they send you to another office, they will usually call ahead to let them know you are coming. In this way, they can premeditate their characters just like an actor or an actress and play you anyway they want using their energy and the family way, with or without lies. Using SMARiTT to monitor, control, and time things like that, gives them an edge that is almost impossible to beat. Combine that with the fact that they can play you like you are dishonest or not doing it right and they are honest and doing it right because they have an important job and no one would believe you anyway, gives them alot of confidence and audacity. Besides that, they are the ones in charge of "the system" anyway and nothing will get done unless they do it. These people are also in charge of who gets in, who gets what, who is not allowed in, and so on, and so on.

Using SMARiTT to monitor people and their thoughts makes it possible for them to play you anyway they want and premeditate their characters before you ever even get there.

Most government employees know the family way and have to go along with it whether they want to or not. Especially if they want to keep their jobs. Not all government employees necessarily want to go along with it, but it is dictated by management and they are in charge of promotions. I want to make it clear that there are still some good people around and I have gotten a little help from them, but on the whole, it is almost impossible to get anywhere or anything done when management is remote controlling your progress with SMARiTT and psychology taught to government employees the family way.

Psychiatrics

Psychiatrics is the medical science of using drugs and medications to treat people with mental, emotional, or psychological ailments.

Psychological Warfare

Psychological warfare has been a practiced science since WW2 minimum. It is used by the military, CIA, other intelligence agencies, and then some. Psychological warfare can be used by anyone who knows what it is, how to use it, and can get away with it. Psychological warfare was developed with the use of SMARiTT. Monitoring people with SMARiTT made it possible for the people using SMARiTT to see how people react to particular situations or to psychology designed to manipulate or attack someone. If the science of psychology were designed to help people, then the science of psychological warfare would be to hurt or destroy people.

The Management of People as a Science.

The management of people is a science. I suppose it could be called managementology, but I don't know if that is a word and it is a little long anyway.

One aspect of the management of people is the rank structure. Once it was explained to me as a pyramid. One person takes in two people and gives the orders to them. Those two people take in two more people and give the orders to them. Those four people each take in two people and give the orders to them. Those eight people each take in two more people and give the orders to them. Now were up to sixteen people and it just keeps going and going and going. In this way the people on top of the pyramid outrank everyone below them and can use the rank structure in many different ways. This way is kind of systematic, but it works and in this way it only takes twenty-nine levels to cover the entire United States of America. I did the math for you just so you could see it on paper.

Rank structures are also used in the two division way. The two divisions are commonly referred to in several ways. Management and laborer, white collar

and blue collar, officer and enlisted, commissioned and non-commissioned, and many other ways.

By using the pyramid structure and the two division way together, it only takes half the resources to manage twice as many people.

Rank structures are used in just about all businesses, government agencies, and so on. The church even has a rank structure. In a way, it is necessary to have a rank structure or an organization of people, so that people working together for a common cause can be more organized, know more about what they are doing, and to make it possible to get things done. On the other hand, no one can make you do anything you don't want to do, or force you to do anything against your own free will. Especially here in America.

Another aspect of the science of management is to keep records of people. Your birth certificate and social security number are examples of records used to keep track of you or to know more about you. Everytime you fill out paperwork it can go into a file or a computer so that someone can find out more about you. Keeping records of people can also help someone track or locate another person.

Another aspect of the science of management is the ability to plan or organize events or projects. Even when it comes to planning or organizing events or projects, the main aspect of planning and organizing the events or projects is managing the people involved.

Using SMARiTT for the management of people is a most powerful tool. With SMARiTT, the people who have access to it can research anyone's past, explicitly, all with audio, video, and eewave recordings stored in a computer. A person's whole life is recorded and stored on computer microchips. This information, as of right now, is only accessible by certain high level government officials and the people they let in the family way. Since SMARiTT doesn't officially exist yet, they can use this information for whatever they want. SMARiTT is the most powerful way to control and manage people. SMARiTT is also a most powerful tool to plan and organize events.

There are companies in the United States of America that have hundreds or thousands of employees and with the proper management systems they can maintain to be able to manage them all. The federal government has millions of employees and with the proper management systems they can maintain to be able to manage them all. The United States of America has approximately two-hundred and forty million people in it and with the proper management systems it is possible to maintain to be able to manage them all. Especially with SMARiTT.

Pictureology

Pictureology is the science of studying pictures. The science of studying pictures is a real science, but I don't know if the word pictureology exists, but that is what I decided to call it. Pictureology is taught and used in certain intelligence agencies for the purposes of national security. Scientists study all kinds of pictures. They study pictures of the Earth, taken by satellites. They study pictures of other planets, taken by satellites. They study surveillance

tapes. They study flat pictures and moving pictures. Part of the science of studying pictures is to determine if the picture or pictures are genuine or not.

Pictureology also includes how to use pictures of people. When most people look at pictures of other people, they have a tendency to try and look inside that person to see if they can see more about them. It had been said, when pictures or photographs were first invented, that a person could see the soul of the other person in the photograph. Using pictures of people to create perceptions of the person or people in the picture is a practiced science. It is taught and used in the press, media, and entertainment industries. Magazines, newspapers, television, and alot of other medias use it to create images or to portray people anyway they want, good or bad. People use their energy in all kinds of different ways. Feelings or emotions like being happy or sad, up or down, good or ill, calm or frustrated, can often be seen by others in the form of natural human energy. This energy can sometimes be seen in the picture and it is why alot of people have a tendency to try and look inside a person in a photograph. Picking the right photographs to depict people, as desired by the people picking the photographs, is a common practice in the business. In reality, unless you were there while the picture was being taken, you don't know what that person was going through at that time. Also, when people are posing for photographs, they general try to project their energy the way they want to be perceived and to get the desired image of themselves. In the business, it is used to sell stories and,or magazines and newspapers.

(Note: I used the word pictureology to define the study of pictures or photographs. Photography is more the science of taking pictures or photographs.)

Communications and Telecommunications.

Communications is a very vast science. In one way, it could be considered the use of electronic equipment to communicate with other people. However, using electronic equipment to communicate with other people could more be considered telecommunications. In another way, communications can simply be the ability to communicate with people. There are many methods or modes of communications. Here is a small list of a few ways to communicate with people just for enlightenment.

Some of these forms of communications are used to communicate from

one person to another. Some of these forms of communications are used to communicate from one person to many people. Some of these forms of communications are used to communicate from many people to many people. Some of these forms of communications may seem simplistic. And Some of these forms of communications might better be described as telecommunications.

The number one main aspect of communications you should become more aware of is the ability of a person to communicate using their energy and the sound or refraction in their voices. A person can communicate things just by using their energy alone. A person can use their energy to intensify or heighten whatever they are saying. By using their energy and the refraction of one's voice, a person can say the same sentence or the same words differently to communicate different variations or meanings of that sentence or words. For example, let's take the sentence "have a nice day". If I were walking down the street and I met a friend of mine and stopped to talk briefly for a moment. At the end of our brief conversation I might say "have a nice day". In this instance I would probably say it casually. If I were at the store and the cashier were giving me a hard time, just before I left I might say "have a nice day". In this case I would probably say it sarcastically. If I were talking to someone and they were feeling a little down, I might say to them "have a nice day". In this case I would probably say it genuinely or sincerely to try to cheer them up. Whether it is said casually, friendly, courteously, sarcastically, sincerely, half-heartedly, or however, it is communicated with natural human energy and the sound of one's voice.

Let's do one more short example. Let's use the words "don't stop". If my girlfriend started to give me a back rub and I didn't want her to, I might say "don't" with a little pause in the middle and then "stop". This would mean that I wanted her to stop. But, if she started to give me a back rub and I liked it, I might say "don't stop". This would mean that I wanted her to keep going. Also, the refraction in my voice would change accordingly to how I wanted it to be perceived.

This part of communications is the most important part of communications. It was and is highly developed and redeveloped with the use of SMARiTT to monitor people and their reactions to such communications in this manner. It is also a part of psychology and psychological warfare. It is taught and practiced in many industries and occupations. Here is a list of just a few.

1. It is taught in the television and movie industry. Actors and actresses learn how to use their energy to portray characters or other people. They learn how to use their energy and the refraction in their voices to say their lines with the proper emotional content so that the meaning is expressed the way it is supposed to. Directors learn it so they can direct the actors and actresses as to how they want them to play their parts so they can choreograph their roles as it is scripted or directed. Newscasters learn it so they can report the news the way they are directed to. And so on, and so on, and so on.

2. It is taught in the radio broadcasting industry. Radio announcers learn how to use their energy to maintain the proper tone of voice to communicate

things across the radio the way they want to or the way they are directed to. A major example of how a person can use their energy and the tone of their voice to communicate things across the radio is back in the days when radio was more of a major media, i.e. before television. A radio announcer used his energy and the sound of his voice to communicate fear across the radio. He was broadcasting to millions of people. He stated something like, aliens have just landed and they have come to take over the earth. It was a complete lie and yet he said it genuinely with the tone of fear in his voice like it was real. This actually put some American citizens in a state of panic and fear when they heard it over the radio. They actually believed it to be true. Because of this incident, certain government officials started to regulate radio broadcasting a little tighter.

3. It is taught in the intelligence communities. The intelligence communities are made up of many government agencies. Some of these people's primary job is to watch or monitor other people eight hours a day for the purposes of espionage and, or intelligence. They don't usually work more than eight hours a day, because this type of work can be mentally fatiguing. They are trained in this aspect of communications so they can determine if a person is being serious or if they are just messing around. They are trained to pay attention to the person's energy and the sound of their voices so they can see if the person is angry, upset, mad, happy, cheerful, or whatever, so as to determine the level of seriousness of whatever they are talking about or communicating.

4. It is taught in the espionage part of the intelligence communities. It is used for psychological warfare and to obtain information from people just in conversation.

5. It is taught in the law enforcement agencies and to the people in the court and legal systems. Police officers are taught to use their energy to dominate yours and to control the conversation. Likewise, lawyers are taught the same thing. Lawyers are also taught how to use their energy to take you in the family way so they can acquire your trust and get you to let them handle it. Judges learn how to use their energy for communications and sometimes they use it like they are bigger than you, the family way, like your mother or father, so they can use the law to punish you the family way. Sometimes, for the psychological effect, they use the line "the judge didn't have his or her coffee this mourning". In this way, they use their energy in a hard, threatening, and, or over bearing way to punish you the family way even harder. Prosecutors also learn and use the science of communications, after all, they are just lawyers too.

6. It is taught in the psychological industry. Medical doctors who treat patients use it to communicate with and assess them.

7. It is taught to most government employees. Not all of them are taught communications as a science, but most of them are taught how to use their energy to communicate things to people. In this way, the people who remote control reality and society with SMARiTT and the family way can control the people even more.

8. And so on, and so on, and so on.

Telecommunications in this aspect is simply the ability to use the science of communications across telecommunications equipment. On the commercial broadcast side, it is used to project the desired images and concepts of the broadcaster. Commercial broadcasting also uses the power of suggestion and hypnosis in subliminal ways to sell products or to get people to believe something is real. Using electronic equipment to broadcast voice and natural human energy has certain abilities to communicate in an alien or unnatural way, because the communications are electronically sent and reproduced. This creates a different level of consciousness, because the awareness or attention span of the person listening is drawn in or focused on the energy of the electronic equipment that the communications are coming through as well as the energy of the person doing the broadcasting.

When it comes to SMARiTT, communications can be transmitted directly into a person's energy. The person subjected to these transmissions of the communications using eewaves doesn't have to have any electronic equipment to receive them. This creates automatic natural doubts, fears, confusion, and a whole lot more inside the person being subjected to them. These communications can be played continuously to wear down or mentally fatigue someone. This can cause a person a lot of other problems too. It can be used to dominate a person's time. It can be used to manipulate or violate a person's natural normal thoughts, feelings, and emotions. It can be used to affect or afflict a person's memory. It can be used to violate a person's mental, spiritual, and emotional growth. It can be used for hypnosis without the permission of the person who is being subjected to it. And so on, and so on, and so on.

With the use of electronic equipment, the transmissions can be electronically altered, amplified, manipulated, played in a loop, or whatever. Now remember, it is not the electronic equipment doing the communications, it is the **people** who are using it that way who are doing the communications. SMARiTT and the people using it in this fashion are responsible for the major majority of mental, emotional, and psychological ailments in society and reality today. Ailments such as, depression, schizophrenia, paranoia, anxiety, Alzheimer's, multiple personality disorder, and so on, and so on.

Espionage

The science of espionage is simply how to spy on someone or steal information without getting caught. The science of espionage is a practiced and taught science in the intelligence communities, the military, law enforcement agencies, and so on. Espionage has always been a part of military intelligence.

Espionage is practiced and used in business. It is used to keep up with the competition. In business some things are standard practice. Such as, going to your competitors store and purchasing their product to compare it to yours. However, to spy on your competitor directly or to steal their industrial secrets is illegal.

Espionage is used by law enforcement officers and private detectives.

They use such methods as keeping people under surveillance, monitoring phone calls, taking pictures, and so on. The purpose for this activity is supposedly to acquire evidence or information on someone in an investigation or a case. Doing it from the ground is almost obsolete and no where near as efficient as doing it with electronic surveillance and monitoring equipment. Especially in the stealth fashion.

Espionage can be as simple as snooping or someone sending someone else to snoop for you, but with SMARiTT espionage takes on a form that never existed before in the history of man. The harnessing of electricity and electronic inventions changed the face of espionage. SMARiTT practically makes black bag tricks obsolete. Since SMARiTT is permanently installed and maintained nationally and internationally in everyone's home, in all buildings, vehicles, airplanes, and strategically placed outside to cover the entire outside and everything else, obtaining information is as easy as punching it up on the computers, watching it on the monitors, and listening to it through the speakers and with eewaves. Using the eewave aspects of SMARiTT on the natural human energy wavelengths to monitor and record a person's thoughts, feelings, and emotions, is the ultimate in obtaining or stealing information. The information is stolen straight from the thoughts of the person thinking it. Espionage as a science has been developed and redeveloped with SMARiTT for several scores.

(Note: Espionage on the international scale is what the "Cold War" was all about. Using SMARiTT to do this with is a highly sophisticated science and a prime example of the reality of the use and existence of SMARiTT.)

Anything or Everything as a Science.

Anything and, or everything can be or already has been studied as a science. Studying anything as a science means to scientifically research it, study it, develop it, and document or record the data. If you wanted to learn more about how toenails grow, you could study it as a science. You could call it toenailology, but it would more likely be a medical science. If you wanted to know more about how bricks are made, you could study it as a science. You could call it brickology, but it would more likely be a technology. These two examples are a little exaggerated but the main point is that if you wanted to learn more about anything or everything you could study it as a science. Anything you wanted to know about or were curious about can be or already has been studied as a science.

Here are a few examples of just a few sciences. If you wanted to know more about the planets and the stars it would be astronomy. If you wanted to find out more about the fiction and imagination concerning the planets and the stars it would be astrology. If you wanted to learn more about how airplanes fly it would be aeronautics. If you wanted to learn more about how to put make-up on it would be cosmetology. If you wanted to learn more about plants it would be botany or horticulture. Botany as a science goes under the broader label of biology. If you wanted to learn more about or study anything it would be a

science. Chances are it has already been studied as a science and it has a name. If it doesn't already have a name, you could give it one. If you discovered or developed anything new in that field, you would be a scientist.

Back in the earlier part of this century, electricity and inventions were thought to be power. Knowledge was also thought to be power. After all, electricity and inventions came from knowledge in the first place. When mass production started to generate mass tax revenue for the government, the government, i.e., the people in high level government positions who had power and influence over the federal budget and taxation, had a lot of extra money to spend on whatever they wanted. They did then and still do now, spend as much as they want on science and technology for national security, defense, or whatever. They have been doing this for over a century. Even though it is taxpayer's dollars and it belongs to the American people for our security and the security of our families, the people are kept out. The only people who have access to all of this knowledge are management and the people they let in the family way.

"Science and technology" is one of the major labels in the USA in which large amounts of taxpayer's dollars are spent. Management, as an organization or group of people, have already had everything and anything you could think of researched, developed, and studied as a science. This is done by contracting people and companies to do it for them. Today, trillions of dollars are given away to multi-billion dollar companies and other people for the research and development of everything. All of this knowledge is centrally controlled, maintained, and managed by management. They are the only people with security clearances high enough to access this information and they are also the people who classify it to determine what the people are allowed to know, what the people are not allowed to know, who is allowed to know, who is not allowed to know, and to what degree they are allowed to know too.

Using SMARiTT to study, research, develop, and redevelop sciences is a very powerful tool. Using SMARiTT to monitor the people working on this stuff is also a very powerful tool. Using SMARiTT to steal other people's thoughts, ideas, and inventions is a very powerful way to acquire more and since SMARiTT doesn't officially exist yet, you can't say or prove they did it.

The Government (Management)

We the people of the United States of America are the government. We choose and elect the people we want to be our leaders and to represent and work for us. By the Constitution of the United States of America and by our laws and way of life, our elected officials are supposed to be in charge of and running the country the way we want them too. They are all under oath to serve the American people honorably, which means they have to tell the truth and keep the people informed as to what is going on in our country, so together we can properly make the best decisions to insure and secure the security and prosperity of ourselves, our families, our country, and the real way of life.

But, there is another group of people, within our government, who have as much power if not more than our elected officials. I call them management. These people have high level, permanent life time positions in our government. They were not elected. They were brought up the family way and given that position by the people who promoted them. They have been around longer than most of our elected officials. They outrank everyone and they run the government with authority, the family way, the company way, and the people way. They are in charge of and oversee national security, science and technology, the military, the intelligence communities, law enforcement, and all other aspects of government. They own or control everyone with contracts and security clearances. They have more power over the federal budget and taxation than our elected officials, because they have been around a lot longer and know how to get what they want. These are the people who draw up the contracts that own and control people for the rest of their lives.

When I say they run the government like a company, I mean just that. The United States government as a company has the highest income and more employees than any other company or major corporation in the United States of America and probably world. All government agencies are managed by the same people, the family way, at the higher levels. Their income is taxpayer's dollars, so it is pretty much free money to them and they can spend it on whatever they want and raise our taxes as much as they like. They own all of the people as their very own employees and they are the bosses. Most of these employees are under a contract that was written by management, anyway they wanted to write it, and since management oversees the law, it usually goes the way they want it to in court also. They are in charge of salaries and they generally promote the people they want, the family way. They are also in charge of who gets in, who gets hired, who gets fired, who gets promoted, who is not allowed in, and all other aspects of running the government like a company. Using SMARiTT to manage all of these people is a very powerful thing.

Management is completely in charge of SMARiTT. They are the ones who wrote the contracts that compel people to keep it a secret. They are in charge of the security clearances and classifications behind it. They determine how much of it the people are allowed to know about. They determine how much of it is allowed to be sold on the commercial market and who is allowed to buy it.

They are like the sole proprietors of it, all financed with taxpayer's dollars, and held under very tight government security, as determined by themselves. Management are also the people with the highest level of access to SMARiTT and the number one users. They can pretty much use SMARiTT for whatever they want, since it doesn't officially exist yet anyway, as determined by themselves.

There are two other points I would like to make about management. One is that they are all just ordinary people like everyone else, but they have been around a long time in a government capacity. Two is that they are some of the richest people in the country, monetarily. Individually they have extremely large personal bank accounts in the billions, trillions, or more.

The Federal Funding and Financing of SMARiTT.

SMARiTT is one-hundred percent financed with taxpayer's dollars. It is permanently installed, managed, and maintained with taxpayer's dollars. It is also researched, developed, upgraded, and innovated with taxpayer's dollars. It does belong to the American people for national security and for the security of ourselves and our families.

Here in America there is no taxation without representation. This means no one can impose taxes upon the American people without our consent/vote and without telling us where it is going and what it is being spent on. Everything and anything that taxpayer's dollars are being spent on belongs to the people for our security, the security of our families, and the quality of our lives.

But, here in America, management is mostly in charge of the federal budget and taxation. Even though they have to report to us about where our money goes, they don't. They use labels and what they call general funds to substantiate where our money goes. A few of the labels or general funds tax dollars go under are defense, science and technology, social security, education, intelligence, law enforcement, and so on, and so on. Even the general fund labels have general fund labels. This makes it almost impossible to find out where the money goes. They can even say it is classified and you are not allowed to know.

By using SMARiTT to manage the people and to keep everyone out, they can pretty much do anything they want with our money and they don't have to keep their books in order or report it to the American people. Here in America there are multi-billion dollar companies who not only can keep track of their finances, but they have to or the IRS would be crawling all over them. The federal government as a company has a higher income and more employees than everyone else and is perfectly capable of keeping the books in order. Accounting for the money is the simple task of book keeping. However, the books are not kept properly and no one really has access to them. The IRS is a government agency, under the control of management, and they are used to monitor and keep track of the finances and accounts of every single American business and of all the American people individually for taxation purposes. There are no firms or agencies to keep track of or monitor the federal budget. That's income or expenses. Occasionally they do put a little bit of it out in the press

or media. However, whether it is accurate or not who would know and how could you check it out for yourself anyway.

(Note: If the IRS can keep track of every single person's income, that's about two-hundred and forty million people, plus keep track of every single American businesses' income, that's about alot more than I know, all for the purposes of taxation, you can see that it wouldn't be that hard to keep track of the federal budget and spending.)

Security Clearances

Security clearances are basically designed to keep people out. They are designed so that no one is allowed to know what's going on or what's being researched and developed in the United States or in the science and technology communities unless they have a security clearance. In order to have or get a security clearance, you must be under a contract saying they own you forever.

When I was in the military (US Army) we had three levels of security clearances, but there are actually five levels of security clearances. The three levels of security clearances are confidential, secret, and top secret. The other two levels of security clearances are, no security clearance and management.

In order to work on anything that is considered sensitive or classified you have to have a security clearance. In order to get a security clearance you have to have a contract saying they own you forever.

All security clearances are on a need to know basis except for the fifth level (management). Even people who have top secret security clearances are on a need to know basis. Which means they have to report to management why they need to know.

The fifth level of security clearance people are the people in life time permanent high level government positions who run the government and the country, "the family way", like a company. (Their own company). These are the people who outrank everybody. They are in charge of who is allowed in, who is kept out, what is allowed to be publicly known, what is to be classified and to what degree or extent it will be classified too. They are also in charge of the level of security clearance a person is allowed to have and since all security clearances are on a need to know basis, these are the people you have to tell why you need to know so they can decide if it is okay for you to have the information you are requesting. These people are also pretty much the owners of the contract. Which means they pretty much own the people under contract like property.

Many government employees and a whole lot of other people are under a permanent life time contract saying they are owned for the rest of their lives by management. All of the people who know of or have access to SMARiTT are under contract and are not allowed to tell anyone it exists. Just because a person is under contract doesn't necessarily mean they have a security clearance. Security clearances are used mostly for the people who work on and develop this stuff. Management decides what level of security clearance a person gets, according to what they need them for. Security clearances can

also be revoked whenever management determines they don't need them anymore or when the job is finished.

Besides the science and technology fields, security clearances are used in many high level government agencies. The military uses them, federal investigators have them, intelligence agencies use them, and so on, and so on. Wherever management determines security clearances are necessary, that's where they are used.

Contracts

A contract is a formal written agreement on paper. All contracts are written or drawn up by a person or group of people. Contracts don't just come from the system. A contract can be written anyway that person or group of people want to write it. A contract is not legally binding until it is signed. Here in America no one can legally make you sign anything. According to the 14th amendment of the Constitution of the United States of America no one can compel anyone else to do anything against their own free will. All contracts can only be enforced by law. Any contract can be challenged in court, by law.

The federal government and many companies and businesses use contracts. Contracts are an everyday part of life for most people. Here is a list of common everyday contracts most people are familiar with.

1. When you fill out an application for employment you have to sign it. By signing it you have given permission to the prospective employer to research your past employment history, where you went to school, and more.

2. When you buy a car from a dealer you have to sign a contract. By signing this contract you are stating you have read, understand, and agree with the conditions of the sale. For the dealer, it insures any liability against him and gives him permission to repossess it if you don't pay for it.

3. If you rent or lease something, you have a contract with the person or company renting or leasing it to you.

4. If you own a home, you have a contract with the bank or your loan institution stating the terms and conditions of the loan. Also, when you buy the house, you sign a contract stating the terms and condition of the sale.

5. In business contracts are used everyday. Formal written agreements are made to protect all parties involved in a deal.

6. Just about everything you sign or have to put your signature on is a contract.

7. If you buy a product that has a written warranty, the warranty is a type of contract. It's legally binding, but you don't necessarily have to sign it. Some companies want you to fill out a card and mail it in though.

Contracts can be written very powerfully. Some contracts even surpass the law. Now, as I said, no one can actually make anyone sign a contract legally, but it is done all the time. There are many ways to pressure someone into signing a contract whether they want to or not. Especially using the family way, enforced with SMARiTT.

Here are some of the reasons why people have to sign a contract

whether they want to or not.

1. Getting a job. When it comes to filling out applications for employment, employers can pretty much write their applications anyway they want. If you don't fill them out, you don't get the job. If you do get the job and the job requires you to sign a contract to hold that position, if you don't sign the contract you won't get the job or that position. Even if the contract says the company owns you. Without the job, you won't make any money, and without money, you can't survive in the monetary world.

2. Buying a new car. When a person buys a new car they have to sign a contract. Now, for starters most people who know the family way and have reasonably good jobs know they generally have to buy a new car just about every five years. If they don't buy a new car when it is suggested to them, the family way, they could be fired from their jobs, the family way. When they go to the dealer to purchase a new car, the salespeople are trained, the family way, to sell them a car using the red book. The red book in business, on the public scale, means to use the power of persuasion, enforced the family way, secured with SMARiTT and the law, by contract or whatever. Salespeople are often taken in, the family way, and brought up to use this method of high pressure sales. In business, they say it works, that's why they use it. In reality there is no way it would work unless they could back it up with criminal activity, planned and secured with SMARiTT, and using the law, the family way.

(Personal note: The "red book" way of business is actually, completely illegal. It is promoted, controlled, and maintained by management, the family way, with the use of SMARiTT and controlling the law the family/company way, with or without contracts. The truth is, if they couldn't really do it, it wouldn't really work. Also, it clearly shows how SMARiTT [national security equipment] is used and how reality and society have become remote controlled.)

3. Buying a house. Buying a house can be similar to buying a new car, but different. A house is a much bigger investment, so they can't push it as hard. When you do find one that you want, you have to be careful about the financing contract you sign. Even if they use the family way to take you in like a friend or like it's good, if the contract you signed turns out to be a rip-off, it goes down as what they call a legal rip-off.

4. In business. If you go into business for yourself it is most likely that you'll have to sign contracts. Sometimes it is the family way to take advantage of people who are just getting into a business for themselves. Taking advantage of people when they are down is fairly common. The need to get going or keep going in business can sometimes override the so called, bite in the ass, you have to take to do it with. This can be commonly viewed with SMARiTT. Also, in business you will probably want and need to use contracts to protect your investments and assets. But sometimes in business, if the other party reneges on their contractual obligation, it could come down to which way it goes, the family way, in a court of law.

Contracts can also be written very tricky, confusing, and/or deceptive. For example, a contract may have a clause in it that is written to sound nice, fair, or even okay, but if or when they use it against you, it can seem to be very

unfair or even illegal. Also, a contract can have just one sentence in it that contradicts the entire rest of the contract. When this happens, it comes down to which way it goes in court. Most of the time it goes the family way, and this is what is meant by if you are big enough. Also, a contract can be written with just two words that contradict themselves, in just one sentence, and this can void the entire contract, making it a rip-off or invalid. Writing contracts like this is usually done on purpose to take advantage of people. Since a lot of people are pressured into signing them anyway, it works rather well. Also, there is the people factor, the psychological factor, the time factor, the education factor, and the money factor.

The people factor is the person whose job it is to get you to sign.

The psychological factor is part of the training that a person gets, whose job it is to get you to sign. Psychology is a modern, standard business practice. It is taught to people in management positions in most of your larger companies and corporations.

The time factor is many things. The time factor is how much time you have to actually read the contract. It's also how fast you need to get the product or service you need. In business, time can really be money. For new start ups, it can make you or break you. The time factor can also be how fast the salesperson can pressure you into signing, using psychology and intimidation the family way.

The education factor is how much education the person signing the contract has. First of all, most American citizens have very little education about the law. The law is the only legal way to enforce contracts, but the people involved in the litigation of the law sometimes have a tendency to twist things up the family way. The law is not taught in high school. Going to college to learn law can be very expensive and is not really practical unless you want to become a lawyer. The legal system and the people who manage it have designed it to keep people out, make it more time consuming than it has to be, make it more trouble than it's worth, give people the run around, and make it very expensive (financially).

The money factor is just that. If you don't have enough money saved up, you probably aren't going to get anywhere anyway. If you do have some money saved up, you may be faced with the choice of whether or not you want to spend it on legal fees and costs, with the possibility of losing the case and your money, or whether or not you want to let it go. If you have a regular job, you may not be able to take the time off from work that would be necessary to pursue such a case. Getting a lawyer can be expensive. The management of the legal system is purposely designed to be costly. The legal system is also often used to take money away from people to punish them for not going along with the family way or for not doing what they are told, the family way, when they are supposed to. And so on, and so on, and so on.

All of these factors play a part in the business of contracts. Taking advantage of people, by the people who have access to and use SMARiTT, is pretty much standard common business practice. Most of the time the individual can be monitored with SMARiTT first. In this way, the people using

SMARiTT can size up the person being monitored to see how far they can go with them, how to play it, and what they can get away with.

This book/report is about SMARiTT, but officially SMARiTT doesn't exist yet. The reason why it doesn't officially exist is because the people who remote control reality and society with it, want to keep it to themselves so they can use it for whatever they want. This is done with contracts and security clearances. They drew up their own contract using a federal government capacity. There are millions of people who know of and have access to SMARiTT. Some of these people go along with it of their own free will, but most people were forced to sign a contract against their own free will and they have to go along with it whether they want to or not. All of the people under a SMARiTT contract were taken in the family way. Everyone else is kept out. If a person who is not under a SMARiTT contract were to say it existed or that it was used to commit a crime against them, they would be called crazy or psychologically insane and discredited. People who are under a SMARiTT contract know they are not allowed to tell anyone else about it.

To the people who are under a SMARiTT contract: First of all, the contract you signed doesn't officially exist. If it did, it would prove that SMARiTT existed. Secondly, contracts can only be enforced by law. So if they were to say you violated it, they would have to give you a fair trial to prove you violated it. Since there are no laws on the books about SMARiTT and SMARiTT doesn't officially exist, they could only charge you with breaching a contract that doesn't even officially exist, concerning something else that doesn't even official exist. If they tried to charge you with breach of contract concerning SMARiTT and they gave you a fair trial, as soon as the paperwork were filed in a court of law, it would become a matter of public record. Once it becomes a matter of public record, the press and the public would know about it, making the contract obsolete and unenforceable. Thirdly, if this contract binds you in any kind of illegal way, you have a right to challenge it in a court of law. Like I said, if it goes to court, it becomes public knowledge anyway and that makes the contract null and void, obsolete, unenforceable, illogical, groundless, erroneous, and invalid. If you know many people under this contract who would like to challenge it, you could start a class action. With a class action it wouldn't be likely that they could charge you or anyone else with anything.

To the people who are not under a SMARiTT contract: There are at least a few million people within the USA who are under a SMARiTT contract. Here is a small list of some of them.

1. Anyone who has a business that makes at least a million dollars a year or more. Most of these people have purchased this type of technology to monitor their own establishments and employees for the purposes of industrial security or whatever. This type of equipment and technology can be purchased from security specialist companies in the security industry.

2. Most of the people who work for large companies in executive positions and make a hundred thousand dollars a year or more.

3. Most of the people who work in the television and movie industry. Actors, actresses, movie stars, newscasters, camera men, reporters, and so on.

Especially those making large incomes.

4. Anyone working in a government capacity directly related to SMARiTT.
5. Anyone working in a high level government capacity including the president, congressmen, military, intelligence, and so on.
6. Local, state, and federal policemen.
7. People who work in the science and technology industry and fields.
8. The people in higher up positions in the press. That's newspapers, magazines, and television.
9. People who work in the law and legal fields. That includes judges, lawyers, prosecutors, bailiffs, court reporters, and so on.
10. Doctors and other people in the medical industry. Especially psychologists.
11. And so on, and so on, and so on.

Basically the demeanor of the people in charge of SMARiTT is to keep everyone out and prevent people from knowing about it. But, if they can't keep them out, they have to take them in with a contract and the family way. People who make a lot of money or hold jobs in important positions, often have to be taken in with a contract, because it is hard to prevent them from finding out anyway. If you have enough money, you can purchase this kind of technology from a security specialist company or from your local spy tech shop. It doesn't take long to put two and two together, to figure out that, that's how they kept you out and down in the first place. By using SMARiTT to monitor you to see what you're doing or working on. Like I said, basically they use it to keep you out first, but if you are going to make it anyway, then they have to take you in the family way and get you to sign a contract that doesn't officially exist, about something they don't want anyone to know about, so they can continue to use it for whatever they want, and to prevent people from making it, all at taxpayer's expense.

Now, if you are not under a SMARiTT contract and you have a friend or know someone in a position like the ones listed here or similar, ask them about it. If they tell you off the record and you don't tell anyone about it, they can't be charged with violating their contracts. You could also call your congressmen or the local police and ask them. All government officials are under oath to serve the American people honorably. If you call them and they lie, they have violated their oath and are not fit to serve the people of the United States of America. If you have a lawyer, you could ask him or her under the client/lawyer confidential law. As soon as SMARiTT becomes officially, publicly known, all the contracts concerning the secrecy of SMARiTT become null and void, obsolete, unenforceable, illogical, groundless, erroneous, and invalid.

Intelligence and Communities.

Intelligence in this capacity, simply means to acquire or gather information on people or whatever and store and maintain the records there of. Intelligence is a very vast field. Intelligence is kept and maintained on all American citizens as well as gathered abroad on all other countries. Intelligence here in

America is used for the management of the American people. The intelligence that is gathered abroad is used to know what is going on in the world and for military capacities. All this information is stored and maintained in national security computers. All the computers of all government agencies can be accessed and controlled, centrally, by management. Management are the only people with security clearances high enough to access these computers centrally. Most of the people in all of the government agencies are simply government employees under the control of management.

Here in America, the old way to do this was mostly on paper and then it was stored in computers. Here is a small list of records that are kept on everyone and stored in computers.

There are many government agencies set up to gather and maintain intelligence on everyone and everything. Intelligence is one of the major labels in which large amounts of taxpayer's dollars are allocated too. All of these agencies are what is known as the intelligence communities. Here is a small list of intelligence agencies.

NSA - The National Security Agency

The national security agency is the largest and most heavily financed intelligence agency in America. They have hundreds of thousands of employees whose sole purpose in life is to watch and monitor everybody. Even though they are the biggest intelligence agency in America and they are one-hundred percent financed with American taxpayer's dollars for the purposes of national security, the statistic I heard was that ninety percent of the American people don't even know they exist. Their main base of operations is in Virginia.

CIA - The Central Intelligence Agency

Back in WW2 the federal government set up an organization called the OSS (Office of the Secret Service), which later became the CIA. The CIA was originally set up to gather intelligence abroad during wartime. CIA agents were then and still are now trained in such fields as espionage, communications, gorilla warfare, psychological warfare, black bag tricks, sabotage, and so on and

so on. The CIA was originally not suppose to operate within the United States of America. Today, who knows. Also, remember that all CIA agents are just ordinary American citizens who were recruited or taken in the family way to serve their country.

(Note: Black bag tricks are how to pick locks, crack safes, access computers, penetrate security systems, get into buildings or rooms without getting caught, and stuff like that.)

MI - Military Intelligence

FBI - The Federal Bureau of Investigation

The State Police - The County Police - The Local Police

(Note: For this small list I just wanted to write a little bit about the first two.)

Every and all government agencies can be and are used to acquire and maintain information on everybody. If you would like to get an idea of about how many agencies there are, you could just look it up in the telephone book. Just check the blue pages of the white pages, but remember, not all the government agencies are listed. Acquiring intelligence can also be as simple as someone asking one of your school teachers about you or even asking your family or friends about you. Doing it in this way is considered "from the ground". Even accessing the computer document records is fairly low rate compared to the SMARiTT records.

SMARiTT is the number one most powerful computer records and source of intelligence on anybody or everybody. Since SMARiTT doesn't officially exist yet and management are the only people who can access it, they can pretty much do whatever they want with it. Furthermore, our elected government officials cannot access the SMARiTT records without management's permission. They are kept out with security clearances. However, if they want a background check done on someone, they can fill out the proper paperwork and management will do it for them.

The Hollywood Connection

There are many connections between Hollywood, high technology, and SMARiTT. For the purposes of this report, I'm using the term "The Hollywood Connection" to label the movie and television industry. It also labels the entertainment industry in general.

For starters, cameras and the technology of movies was originated by scientists and inventors. In fact, all of the technology of the movie and television industry came from scientists and inventors. Thomas Edison had a major role in this. His kinetoscope started off the moving picture industry. His invention of the phonograph kicked off the music industry. Also, without his

invention of the light bulb, there would have been no kinetoscope or movie projection.

As the moving picture industry and the entertainment industry in general grew, it became a lucrative one. It grew into a national market and the people who owned the companies were making mass revenue. They used this money to finance the further research and development of high technology. In fact, the research and development of high technology itself is a lucrative industry.

Television was around in the 1920's, but it didn't become an industry until about the 1940's. It was about the 1950's when the television industry became a major money making industry. Since television was around in the 1920's and it didn't become an industry until the 1940's, it means they researched and developed it's uses in a stealth fashion first.

Because the entertainment industry is such a high profit industry and most of it came from science and technology, it has deep roots in the research, development, and use of high technology and SMARiTT.

Another connection between Hollywood and the remote control of society and reality is the fact that they put alot of real technology in the movies. In a way, they do it to put it out that they have it, but you can't say it is real because you saw it on TV or in the movies. If you were to say it was real and you saw it on TV or in the movies, they could say that it is just a movie and that it isn't real, even though it is. In a way, it is how they let everybody know what they have without anyone being able to prove that it really exists. In essence, they subliminally let everyone know what they have, but you aren't allowed to know if it is true or not. Also, they put alot of fake stuff in the movies, just to throw people off, to further confuse them, so they don't know if it is real or not.

Another connection between Hollywood, high technology, and management is that today there are many multi-billion dollar entertainment companies who receive billions of free taxpayer's dollars a year for the research and development of high technology. For the purposes of this report, I'm using the amount of billions, however it really could be in the trillions.

Another connection between Hollywood and SMARiTT is the fact that the movie and entertainment industry is a lucrative and seductive one. Management has overseen the television industry from the beginning. Management has deep roots in the industry and they regulate it with federal government capacities, the law, contracts, and the family/ company way. All of the major stars, such as; actors, actresses, singers, and the like are all under contracts that own them for the rest of their lives and they all have access to SMARiTT for their own personal entertainment.

Another connection between Hollywood and the remote control of reality and society is the fact that the people who work in this industry have mastered the art of using television and cameras for illusion. They have mastered the art of making things look real. They even make gun battles, explosions, and killing look like fun. Using highly sophisticated electronic equipment to do this with is a science.

There are many other connections between Hollywood, SMARiTT,

management, federal financing, and the remote control of reality and society. I just wanted to write a few of them here.

The Remote Control of Reality and Society Using SMARiTT and The Family/Company Way.

The remote control of society and reality using SMARiTT and the family way, the company way, and the people way should be pretty obvious to most people. The remote control of society and reality is also done with psychology and acts and characters taught to people for the purposes of, not only remote controlling society and reality, but to pretend SMARiTT doesn't exist. Everyone has come into contact with this or has been affected by it before. There are so many things I could write about it, that I could write an entire book on the subject, but for the purposes of this book, I am only going to write a few examples and you can think about the rest.

1. If you are sitting around your house and you are thinking about going to the store, if the people monitoring you with SMARiTT want to play tricks with your mind or instincts, they could have someone waiting at the store for you. When you go to the store, that person could play their character the way they are told to do, the family way. While that person is doing what they are told to do, the family way, the people using SMARiTT can monitor the situation to see how you handled it or what else they can get away with.

2. With SMARiTT, the people using it can listen to everything you think. Since everything you do or are working on is a thought first, they know everything there is to know about you. If you have planned an event for next week, they know and can manipulate it however they want. If you come up with a new business idea that will increase your business, they can use it too and they don't have to wait to see you use it first. If you come up with a new product or invention, they can steal it. Since they oversee the law, they pretty much know how far they can go and what they can get away with.

3. Since the police use SMARiTT and they are all radio equipped, they can remote control society and reality directly and know which way they are going to play it when they show up.

4. Here in Seattle, all Metro bus drivers are equipped with phone communications. They also know the family/company way. So, if the people using SMARiTT wanted to mess with someone by remote control, they can just call one of the drivers and tell him or her how to play their characters.

5. When someone comes up to you the family way and asks you to play a character for them, you know it is remote controlled the family way with SMARiTT. Generally they teach you how to use your energy and to say what they want you to say, the way they want you to say it. In essence, you are playing a part or a role like you are an actor or an actress on TV. While you are doing this, the people monitoring it on SMARiTT are watching to see if it worked and how far they can go. If you don't do it for them, they can play you like you are not part of the family and they can get you later. Thus, proving beyond a shadow of a doubt that it is backed up, monitored, and maintained with SMARiTT

and the family way.

6. Everybody who has been taken in the family way and has access to SMARiTT knows the remote control of society and reality. They are all equipped with phones also. So, the people who remote control society and reality with SMARiTT can simply call them and ask them to play a character for them. Even if they don't have access to SMARiTT, they can still be called and asked to play a character the family way, because most people know it is real anyway.

7. All government workers are taken in the family way and taught to do what they are told to do, the way they are told to do it, the family/company way. Most of the time they have to do it whether they want to or not, because if they don't, they could lose their jobs.

8. And so on, and so on, and so on.

In some of these cases, not everybody wants to do it, but they have to go along with the family way. In a lot of these cases, people find different ways to handle it so they don't have to go along with it. I have personally met all kinds of people and most people would rather do it right. I personally never do it because I know what it is. Either way and irregardless, it is absolute proof of the remote control of society and reality, the family/company way, using SMARiTT.

(Note: As soon as SMARiTT becomes officially, publicly known it will never be used like this again.)

The Family Way/The Company Way/The People Way.

Since I wrote so much about the family way, the company way, and the people way, I decided to write a brief description of about what they are.

The family way is basically the term they use to take you in. I have been in many parts of this country and in several other countries. The family way is used all over the place. It is basically the same everywhere and it is a little different everywhere. I have seen management teach it to some people one way and to other people another way. I have seen them teach it to people wrong and all kinds of other stuff. Personally I use it to tell the truth and to care about the people I care about. The real family way is to care about your family and friends and to not let anyone hurt them.

The company way is the term they use to take you in with loyalty to the company. Even if it is a low paying job and the company is giving you the shaft, you are supposed to go along with it, the company way, like that is the way it is. I personally am an American citizen and I have certain inalienable rights. That of life, liberty, and the pursuit of happiness. Therefore, I established my own company way. If the company is taking care of me, I take care of the company, but if the company is screwing me, screw the company.

The people way is a little different than the other two. The people way really signifies the ability of management to own and control each and every person individually. It also signifies their ability to get to each and every person individually and make them do what they are told to do, the family/company way.

The family/company/people way was basically designed by management to

own and control the American people. In this way, they can run the country anyway they want, without using our laws and without being elected. They purposely keep their names out of the press and remain as unnoticed as possible so they will always be there to tell everybody else what to do. They are the number one users of SMARiTT and they use SMARiTT to take everybody in and to maintain and secure their grip over them. Management are also the owners of the contract and they use these contracts to own people for the rest of their lives.

A Little Bit About This Report.

In this report I used the word "some" in some of the titles. The reason why I'm mentioning this is because I wanted you to know that it is not all. No matter how much knowledge you have, there is always more to learn. Also, I used the word "also" quite a bit. I even had to cut it down a little bit just so I wouldn't use it too much. Also, also implies that there is more, and so on, and so on, and it just keeps going and going.

This report has a tendency to go around in circles. There are certain things in this report that are mentioned several times in several different sections. This is done on purpose because they apply to those sections and probably more. In reality, life has a tendency to go around in circles. What you put out has a tendency to come back to you. It is from these circles that the highest levels of knowledge are acquired.

When it comes to the invention of television, in all of my research, the 1920's was the earliest date I could find. I also couldn't find who invented it. An older person who was around at that time, told me that it was at a 1939 Worlds fair that it first became officially, publicly known and that it went on the public market in 1940. This means that the people who had it and were in charge of it used it for at least 20 years before anyone ever knew it existed. This also means that they researched and developed it's uses in a stealth fashion first.

In this report I used the word "score." For anyone who doesn't know what a score is, a score means twenty years, the same as a decade means ten years, or a century means one-hundred years.

Eewaves have been called several other things. They were originally called "radio waves" after the person who discovered them and harnessed their uses. Then another scientist labeled them "electromagnetic waves" to make the name more descriptive and closer to what they are. They have also been called "airwaves", however, scientifically, the label airwaves is inaccurate because air is not a property of eewaves nor is it necessary to produce or use them.

When it comes to the word "eewaves", I established it. The three "e's" in front of the word "waves" stand for "electronic electromagnetic energy". The reason I devised it was because I found it necessary to diversify the difference between electronic electromagnetic energy waves and natural electromagnetic energy waves. Also it further describes what they are.

The word "electronic" signifies the fact that the electromagnetic energy waves come from the harnessing and controlling of electricity with electronic equipment and not from a living source. The word "electromagnetic" signifies the magnetic properties that come from electricity. Magnetism is an absolute property of electricity and how the energy waves are transmitted and received. Also, all recordings are made magnetically. The word "energy" signifies it's substance and what it is. The word "waves" describes how they go out. It was

described by earlier scientists in this way. The waves go out like the ripples in a pond when you drop a stone in it. The waves also go out in a line of sight, which means they don't bend, they just stay in a straight line. They do go through a lot of materials though. Such as; your house or most buildings, but they don't go through mountains or thick rock walls like caves. However, they can be relayed over or around mountains.

Another way I artistically view eewaves is like the light emanating from a light bulb. They go out equally in all directions and they go through any material that is not thick enough to prevent them from going through. They cannot be received or picked up where the light does not shine or reach. This is why it is necessary to use satellites to relay them around the world.

Natural energy and natural electromagnetic energy waves exist. Natural energy is like the power source. It is where the electricity or the energy comes from. Natural electromagnetic energy waves come from the understanding of how to use your natural energy to communicate or broadcast communications. Natural electromagnetic energy waves could simply be called neewaves (*nee-waves*). The "n" stand for "natural" to signify that the energy comes from a living source.

Using eewaves on the same frequency or wavelength as natural electromagnetic energy waves (neewaves) enables the people using SMARiTT to not only monitor the neewaves, which come out and happen naturally, but they can also monitor the natural energy inside the body. The word "brainwaves" is also a label used to describe the neewaves that come from the brain.

I also had two other names for SMARiTT. One of them was NSSMARiTT (*n. s. smar it*). The "NS" in front of SMARiTT stands for "National Security". It was designed to label the highest level of use and access of SMARiTT. The other name was SMARiTTTER. The "ER" at the end of SMARiTT stands for "Electronically Reproduced." I stuck with SMARiTT though, to keep it more general. Also, I capitalized it to make it stand out a lot more.

Einstein said "all things are made up of energy". I personally understand and know this to be true. However, and with no disrespect to Mr. Einstein, all things are made up of energy, but life's energy is different than the energy of other things, because it possesses and, or produces its own living and, or growing energy.

This report is broken down into sections in the table of contents. The reason for this is to make it easier for you to refer to and to make it easier for me to edit and print.

I wrote this report, to the best of my ability, to be as educational, understandable, and enlightening as possible, and with no respect to current grammar standards. I don't know if I could have made my points the way I wanted to if I used them. Most of the punctuation is the way I wanted to punctuate it, also. So it is not a mistake, I just went with the way I wanted it to be or whatever I thought looked better.

Some Interesting Facts.

Prohibition took place from 1919 to 1933. Prohibition, for anyone who doesn't know, was when the manufacture, sale, and consumption of alcoholic beverages was illegal. Alcoholic beverages had been around for thousands of years and yet certain government officials decided to make it illegal. They even had enough power behind it to make it a Constitutional Amendment.

Just because it became illegal doesn't mean anyone stopped making it, selling it, or consuming it. All that it meant was that the business behind it became illegal and it could be controlled more heavily using the law. Prohibition could be used to blackmail people, control people's careers, discredit people, and a whole lot more. During this time in American history, organized crime, gangsters, and stuff like that, had power and influence over some people, some communities, and some cities. The people who had the most power were the people in charge of the law and law enforcement.

Technology at this time was highly sophisticated to the people who were using it at that time. World War One had just come to an end in 1918 and technology was used for the war. The telephone was installed to a considerable extent. The telephone could be used to listen in on whatever conversations were going on in that room or area. Video film cameras were around for about twenty years and could be used to take pictures of people in a stealth fashion. Television was probable around and could be hidden behind mirrors or something to monitor and record people's lives without them knowing it. All of this stuff could be used as evidence against people to control them with blackmail or whatever.

The moral of this story is that technology was used in a stealth fashion, even back in those days, to own and control people. It was used to remote control prohibition back in those days, the same way it is used to remote control society, reality, and the drug industry of today.

Here in America, there are multi-billion dollar companies who receive billions of taxpayer's dollars, annually, for the research and development of science and technology. Generally speaking, about half of the money goes toward high technology and the other half goes toward the medical sciences. My Personal Business Section

Hi, my name is Frederick C. Morton and I started a home-based mail order business in about April of 1995. This is also about when I started to become a writer. At this time I was living in housing for the homeless. It took me about a month and a half to write my first product. I started to market it in about May of 1995. I put out about two-hundred and fifty flyers to sell it and I didn't receive any orders.

I officially registered and established my business on May 24th 1995. I had been to the department of revenue prior to this to get my business license, but it was twenty dollars and I couldn't afford it at that time. I asked the lady if I could start my business anyway and she said yes, but I would have to get my business license in a reasonable time afterward. The name of my company is "Imminent Diverse Businesses". After I registered my company I started to market my product even more extensively. I put out over two thousand flyers to sell it, but I still didn't receive any orders.

Then I started having little problems with the other residents of the housing project. Nothing really serious or legal, however they decided they wanted me evicted. There was no way they could evict me legally, but this is what happened.

I received several falsified and fraudulent legal documents from the Seattle police department. I checked the legality of them myself. This went on for about a month. Then on June 19, 1995 the Seattle police department showed up at my home to falsely arrest me. I was arrested for tape-recording the officer while he was trying to coerce and intimidate me into leaving my home illegally. Then they held me in jail illegally for thirty hours while they broke into my home and stole all of my personal belongings including my business and most of my important personal legal paperwork. All I had left was what I was wearing and some property I had stored in a locker downtown. They even got my first product before I had a chance to copyright it.

After that I spent about a month and a half trying to use our legal system properly to obtain justice for this. I called over two-hundred phone numbers. I went to see a lawyer at the free legal clinic and he told me that I had a case, but he didn't have time to take it. I called the lawyer referral office. These are the people who have to give you a lawyer when you don't have any money. They gave me the name of a lawyer and I called him. He also told me he didn't have time to take this case, but he gave me the phone number of another lawyer, a friend of his. I called him and he said it wasn't worth taking. He also lied to me over the phone about how the law works. I was completely locked out and denied access to using the law properly, by the people remote controlling reality and society with SMARiTT and the family way.

After this, I considered writing my product again, but decided against it. The reason I didn't rewrite that product is because it would have come out like the first one and I figured they would probably sue me for copying someone else's work. They did get it before I had a chance to copyright it. With SMARiTT and their imposed family way, their chances of getting away with something like that is pretty good.

So, about August of 1996 I wrote a four page letter about the incident and I sent it out to many places. I sent it to about twenty presses, including the six major presses in downtown Seattle. They are; The Seattle Times, the P-I and the four major television news channels (4,5,7,11). I sent it to about twenty government officials, including President Clinton, four or five of his cabinet members, including Janet Reno, the head of the justice department, and several congressmen for the State of Washington. I also sent it to about twenty businesses just to see if I could get a reply. I didn't get any replies from any of the businesses or from the press. I did get a few from a few of the government officials, but nothing really substantial. When it comes to our government officials, I didn't really get replies from the officials who are obligated to do so and the replies I did get were practically nothing. A couple of them were even written the family way. Especially the one I got from Governor Mike Lowry, who was governor at the time.

Here is a little bit about the flyers.

In September of 1996 I started to market my entrepreneurship letter/report. I marketed it from the end of September to the end of November. I didn't get any orders. In October I tried to file a police report with the Seattle police about the theft of my mail, at the post office, the family way. The officer on duty told me he wasn't going to file it and that I should go talk to the people at the post office. I went back to the police station again, in about three weeks, to file that same report. I was hoping a different officer would be on duty. It turned out to be the same officer. I tried to file it with him again anyway. He still refused to file my report. He told me directly that he wasn't going to file it. I asked him if there was any other way to file my report. He smiled, almost laughing, and said "not unless you can get someone else to file it".

I did file a report against this officer, on December 5, 1996 with Sergeant Robert Gebo of the internal investigations section of the Seattle police department. However, Sergeant Gebo never contacted me about this. He also never gave me any official paperwork saying it was officially filed. I asked him for something with his name and signature on it, so I would have proof that it was filed. He only gave me his card, and a nod with a smile, like he was trustworthy and I had to believe him. I also sent a letter to the six major presses, in downtown Seattle, about this. I didn't get anything from them either.

As an entrepreneur, you never quit. I still wasn't getting my mail and I had to come up with an idea to get some money together, so I could continue to

pursue my case and get off the streets. Being homeless and not having any money makes it quite hard to get anywhere or to get anything done. You have to spent alot of your time just surviving. You have to panhandle for food and your other basic essentials, like toothpaste, razors, deodorant, money to do your laundry, if you are lucky enough to have a camp where you can keep your clothes, and stuff like that. The little bit of food stamps you get helps, but you can't really survive off of them. Using money and the monetary system is one of the ways they keep people out and prevent them from having lives or using the legal system properly. Sometimes I laugh about it and think of myself as another country and they have imposed economic sanctions against me to prevent me from having a life or using the law properly.

So I came up with the idea to write a flyer. I wrote the first one in mid December. In being homeless, I had to panhandle just so I could get money to make copies to hand them out. December is usually a fairly good month for panhandling, being the holiday season and Christmas and all. I made two-hundred and twenty copies and handed them out. I handed out thirty of them in the beginning of January.

After that, I upgraded my flyer four times to make a total of five flyers in all. They were all two pages long, front and back. For the purposes of this report, I had to change the margin so they would fit into this report. Since I typed them on computer, I had to give them a name to save them on floppy disc. Since the original idea was to try and get some money together so I could get back up and get thing rolling, I called them "Getting Up 1,2,3, and 4". All except for the last one, in which I call "Getting Up 5 Superboost". This flyer was extra long. I had to change the font and purposely leave some stuff out, just so I could fit it all into two pages. For the purposes of this report, I left it in the same font so you can see how small it was. When it comes to marketing, most people don't want to read that much, just to see what you are selling or what your flyer is about. Hi, My name is Frederick C. Morton and I am homeless at present. I am writing this letter to try and get some help using our justice system to get back up. I'm not necessarily looking for a free hand out. The statements your about to read are true. I'm writing it as short as possible to make it easy to read and it's why I'm homeless in the first place.

In about April 1995 I was living in low income housing and I started a home-based mail order business. This is about when it all started. It took me over a month to put my first product together and start marketing it. I started marketing it in May. I put out over 2500 flyers to sell it. I didn't get any orders.

Then I started having little problems with the other residences. Nothing really serious or legal, however they decided they wanted me evicted. There was no way they could evict me legally, but this is what happened.

I received several fraudulent and falsified official documents from the Seattle police department. I check the legality of them myself. Then on June 19, 1995 the Seattle police department came to my home and falsely arrested me. I was arrested for tape recording the officer while he was trying to coerce me into leaving my home illegally. Then they held me in jail illegally for 30 hours, broke into my home, stole all of my personal belongings including my business, and then prevented me from returning to my home.

All I had left was what I was wearing and some property I had stored in a locker downtown. I lost mostly all of my personal possessions including my business and some personal important legal paperwork of my own.

After that I spent about a month and a half using our legal system properly to obtain justice. I was completely locked out "the family way", by the people remote controlling reality and society with Stealth Monitoring Technology (SMT). Also with the use of psychology and characters taught to government employees and other people "the family way", to keep people out, prevent people from getting anywhere, and to perhaps put the fear into them(as monitored on SMT) to get them to go away. So I didn't get anywhere.

After that I was going to rewrite my product and start marketing it again. I didn't because it would have come out like the first one and I figured they would have probably sued me for copying someone else's work. These are the kind of people we are dealing with here. I have already been marketing it, but I haven't received any orders yet. I didn't really expect to because, I

have no doubt that my mail was and is still being stolen at the post office, "the family way" by the people remote controlling reality and society with stealth technology. This prevents me from making money so I don't have to be homeless anymore and to speed up the justice process so I can get on with my life. It's also designed to make me look discreditable like I don't want to work or like I don't want to do it right the family way.

PS. I've handed out 2000 of these flyers since Dec. 96 and haven't received any replies at all. If anyone has sent me a reply or order please notify the press, the police or myself in person (if you see me outside handing out flyers or whatever). Otherwise I can only be contacted by mail through my PO Box. Thank you again.

A Little Help Can Go A Long Way Life, Liberty, The Pursuit of Happiness, and Security

Hi, my name is Frederick C. Morton and I'm an honest man. I'm also a veteran of the US Army. For months I've been handing out flyers trying to get help using our justice system and to promote my business. I've handed out at least 1100 flyers with the same heading on it as this one or similar. They all have my name and my post office address on it. I don't have a home address or phone number yet because I am homeless.

I am homeless for two years now. Ever since the Seattle police department came to my home, falsely arrested me, held me in jail illegally, while they broke into my home and stole all of my personal property including my first product and some important legal paperwork of my own. I was arrested for tape-recording the officer in my house while he was attempting to illegally evict me. They did this with what I call laughing audacity. Which means they were hard in a threatening and intimidating way, completely confident in their criminal activity, almost laughing.

OK some of you are saying the police would never do that. Their the good guys. Their there to help us. They have taken us all in "the family way" , had sex with us, and they protect us from all those bad people.

Well OK, I say what would happen if you didn't let them take you in the family way, have sex with them, do it the way they tell you, or live your life according to what is dictated the family way with that "you know" stuff. You know they would do the same thing to you. How do you know they would do that? Because you can feel them monitoring you the same as everyone else and it is communicated across stealth monitoring technology.

Stealth monitoring technology is the most powerful weapon in existence today. Technology has been used in a stealth fashion for much longer than it has been used in any commercial or publicly known way. The sophistication of technology is also much higher than what is publicly known. Stealth monitoring technology is permanently installed nationally and internationally. It is very thorough and it monitors society, reality, and every single persons life, 24 hours a day, 7 days a week, 365 days a year without any breaks. It not only continuously monitors everything, but it also records all of it. This is done through a system of audio and video equipment installed in every square inch of this country and via satellite. It is installed in everyone's home, in all buildings, on buses, and in cars. It is strategically placed outside to cover and monitor the entire outside, and so on, and so on, etc. etc. The audio and video equipment alone is very powerful, but the most powerful part of stealth monitoring technology is electronic energy waves (eewaves). I call them eewaves but they are also known as radio waves, air waves, electromagnetic waves or maybe something else. Eewaves are used to monitor the natural human energy inside the human body. Thoughts, feelings, and emotions are natural energy inside the human body, it is what being hard is, and they can be monitored and recorded the same as everything else. All of this stuff is controlled, managed, operated, and recorded with computers. All of this stuff is financed with American tax payer's dollars and is for the purposes of national security.

It is with stealth monitoring technology and the family way that the police can feel confident in their criminal activity.

Here are some very important points about stealth monitoring technology.

1. If the police are the good guys and they haven't done anything wrong, they won't have any problem showing us, or you, the video of any crime that has been committed in society or reality for the last thirty years minimum. That's any crime including murder, rape, kidnapping, missing persons, etc. etc. etc.

2. Stealth monitoring technology (SMT) is paid for by US tax payer's dollars and belongs to the people for national security. You do have a right to know it exists and to be safe and secure in your life. There is no taxation without representation here in America.

3. There are many people who have access to and use SMT. All of these people are under a contract stating they are not allowed to tell anyone about SMT. Some of these people are lawyers, judges, police officers, big business men, people employed in the television and movie industry including news casters, members of the press, congressman, government officials, and more. Now, here in America most government officials and employees like the police are all under oath to serve the American people honorable. Which means if you ask them a direct question and they lie, they have committed perjury. Call these people and ask them about SMT or if you have a friend in one of these categories ask them. If you have a lawyer, ask him or her under the client/lawyer confidential clause.

4. If stealth monitoring technology is used to commit the crime, than stealth monitoring technology is the most powerful, essential, and necessary piece of evidence in a court of law. The court systems are generally ran like television shows, "the family way". Which means the judge, the prosecutor, the attorneys, and the rest of the people involved all play their characters the family way and do what they are told as it is monitored with SMT. Also, if it doesn't go the family way, the opposition may be using SMT to know which way you are going with your case. Similar to Nixon in the Watergate incident, but alot more sophisticated.

5. If anyone comes out of the walls and tries to take you in the family way and get you to lie for them or do something to someone because they want you to. Please don't do it. Don't help them to hurt your neighbors. Besides, if you have to lie, they haven't done anything wrong in the first place. Also, if they are teaching you what to say and how to say it like an actor or actress, you know it is remote controlled.

Now, what prompted me to write this is that for two years I've been trying to acquire justice for crimes committed against me by the Seattle police and the people whom remote control reality and society with stealth monitoring technology. I have written letters all over the place and I am still in business for myself. Recently I have been harassed by the Seattle police department in a life threatening way. Police officers have driven by me and harassed me as such. On May 22, 1997 Officer Kinzey of the Seattle police department stop to get out of his car and personally harass me in a life threatening and intimidating way, while I was panhandling. They are doing it like I'm

not allowed to panhandle to survive. I went downtown to file a report on this, but I was denied. I spoke to officer Marc Olson of the internal investigation section and he went the family way just like I knew he would. I went to at least four other offices to try and get something done, but my efforts were almost fruitless. No one in any of these offices ever heard of official or standard legal paperwork. I was lied to, prevented from using the law properly for my own security, and they all phoned the next guy to let them know I was on the way and to go the family way. This is not the first time this has happened to me, I have a whole list of incidence while trying to use the law properly. That is why I'm writing it to you.

I'm still in business trying to make money for myself so I can get off the street and pursue this properly to prevent this from happening to anyone else and to acquire justice for myself. I have a mail order business, which means I sell products through the mail. I've marketed my products for about two years now. I haven't received any orders yet. I'm absolutely positive that my mail is being stolen at the post office the family way. This is another police report I was denied to file. The fact that my mail is being stolen at the post office the family way can be proven in less than an hour using the press. But the remote control of society and reality the family way with SMT prevents this from taking place until the pressure goes up. If the police are in on it and they are the only investigators, what do you think they would say. They also control the evidence, the phone tips, the people involved the family way with loyalty or fear, and all other aspects of the investigation. No wonder they can be this confident, and with SMT to monitor and secure this activity, the likelihood of them getting caught is pretty slim, but not impossible.

Well, here is how you can help me. You don't have to, but a little help can go a long way. I'm still in business and these are the products I have for sale.

Everyone does have a legal right to make money and they also have a survival need for it. So buy one anyway and learn how to make money at home in your own home-based business. It won't be long now.

3. Presently I am working on a new product. It's not finished yet and will probably take several weeks to complete. I'm barely half done with it. It's a fully detailed report on stealth monitoring technology. It tells you what it is, where it comes from, who's in charge of it, and much much more. It will be for sale for about \$22.00 to \$25.00 when it is finished (sales tax will also be included for WA. state residents). It is sometimes common to take pre-sale orders in business to acquire capital to get started. So, I have decided to take pre-sale orders for this product. I will only accept pre-sale orders in person. I will not accept any pre-sale orders through the mail. The pre-sale price will be \$20.00 (sales tax is included for WA. state residents).

Now, the first two products can be purchased through the mail. But like I said I've been marketing these products through the mail, with flyers similar to this one, since December of 96. I have not received any orders or mail from them at all. I'm still in business and I'm still going. If anyone has sent me an order please notify the press, the police, or myself. If you have already done this, you know they are keeping it in the family way. So, please keep the pressure on and don't let this stop you from ordering through the mail. Only send a check or money order and if you don't get it in ten days you know they stole it. The more they do it and the longer they do it, the sooner they will get caught and together we can prevent this from happening to anyone else.

All three of these products can be purchased from me just about any time. If you see me handing out flyers or whatever, just ask me and I'll be happy to help you. I'll also be happy you helped me.

Finally, because I am homeless I have to ask. Any kind of loan or donation you could help me out with, would be greatly appreciated. All loans would be repaid upon my honor as soon as possible. They are doing their best to prevent me from having money, but their best just isn't going to be good enough.

Revision Section

The Main Reason I had to Revise My Book.

The main reason I had to revise my book was because I no longer wanted to be obligated to two of the products I had for sale in the back of the book. The two products were my “Lifetime Priority Mailing List” and “Newsletters and Reports”. The reason I no longer wanted to be obligated to do these two products is because my energy and momentum have dwindled somewhat. The SMARiTT people went all out for me. “Good” for them”. As far as my Lifetime Priority Mailing List is concerned, I will eventually offer one. As far as my Newsletters and Reports are concerned, not only will I eventually write them, but I will also start my own press and publish them on a much broader scale. As for right now, writing is a little bit harder for me because of the somewhat extreme electronic mental harassment I have to deal with from the SMARiTT people, each and everyday. They really are only prolonging the inevitable and to a much greater detriment to themselves.

*Note: I had one other product for sale in my original SMARTT book. That product was “The Letters and Reports of the Original Incident and Then Some”. This product contained the original letters that I had sent out to the press, our government officials, some lawyers, and some other places, about me being falsely arrested, illegally evicted, and my mail being stolen at the post office “the family way”. It also contained the original police reports I tried to file with the Seattle Police Department and their Internal Investigative Section (Internal Affairs) about my mail being stolen at the post office “the family way” and about the police officers that refused to file my reports. I also sent these police reports to the press and told them about what had happened.

The reason I am not going to offer this product in this, the revised edition of this book, is because this had all happened in around 1995, 1996, 1997, 1998, and so on, which was a few years ago. At the time it seemed more pertinent and immediate. As the time has gone by it doesn't seem as pertinent. This is a standard tactic of the SMARiTT people in conjunction with the people who are in charge of the law, who are also the SMARiTT people “the family way”. After many decades of monitoring people, the SMARiTT people know what the immediate response to somethings are and they can plan that far in advance and know what is going to happen even before it happens, especially when they are responsible for it happening in the first place. They also know how things “blow over” as they say, which means how time affects such things as thoughts, feelings, and emotions inside people. They know that if they take their time, or make things take longer than they should, or if they drag it out as much as possible, or if they hinder, impede, hamper, linger, delay, dawdle, dally, lag, slow down, retard, inhibit, and so on, that the urgency of the situation and the energy of the people involved will diminish. This is not necessary the case for me, especially since I already know this. I will just continue and go about it in another way.

The original product was the letters and reports of the original incident. At the time it only contained the original letters that I had sent out, the police reports that I tried to file with the police department, and a list of all the people and places I sent them too. It didn't contain the response letters I got from some of the places I sent them too. Since this was quite a few years ago, I now have all of the response letters that I am going to get, from all of the places that I am going to get one from. I now also have a better computer with a scanner, so I can include all of the response letters that I did get and put them into this product too. However, since this was a few years ago and since my energy has dwindled somewhat over the years, I have decided not to offer this product in this, the revised edition of my book, but instead I will write another book. The title of the book I am going to write will be, "The Making of SMARiTT Book One", by Frederick Charles Morton.

A Brief Summary of My Up Coming Book, "The Making of SMARiTT Book One".

This book will be written about;

- Why I wrote the original SMARiTT book.
- How long I have been trying to bring SMARiTT out publicly.
- Why it took me so long to market the revised edition of my book.
- Some of the things I had to go through from then until now.
- Some of the things the SMARiTT people have done to me personally over all these years.
- The crimes committed against me by the SMARiTT people.
- My pursuit of justice for these crimes.
- *The letters and police reports I sent out and tried to file.*
- *The response letters that I got from the people and places that I did get a response from.*
- How they used SMARiTT and "the family way" to meticulously prevent me from getting justice for these crimes.
- How they intentionally prolonged the inevitable.
- And a whole lot more.

The Major Revision Changes From The Original SMARTT Book To This, The Revised Edition of My SMARiTT Book.

The major revision changes are as follows;

1. I changed the overall font scheme of the book. I did this to change the overall appearance of the book and to set it apart from the original. The reason for this is because the SMARiTT people are going to have to pay excessively for the first one.
2. I took out most of the hyphens in the hyphenated words that just went to the next line. I did this because I think overall it looks a little better. I did leave a few of them in though, because it doesn't look right with too much space.

3. I changed the word OK to okay. Originally when I wrote this book I wasn't even thinking that the word OK was actually spelled okay, so I wrote it as OK. Since I had to revise my book somewhat anyway, I decided to rewrite OK as okay.

4. I added a few more pages to the Philosophy section of this book. All of the philosophies, truths, and old sayings that were originally in this book are still in here. I didn't take any of them out. I just added a few more pages of them in this, the revised edition of this book.

Truth, philosophy, old sayings, and stuff like that really are what true knowledge and education are all about. There is an old saying, "great minds think alike". The reason for this is because, the truth and common sense are the same for everybody. The truth is common and it makes sense. Although, when the truth is bad it usually doesn't make any sense, however, when this happens you can be sure that there are only people behind it making it that way. Again, the truth is fairly common for everyone.

(Note: I never really did like that old saying, "great minds think alike" much, because it is mostly used by the smart people who think they know it all and usually undermine everything. The truth is that it is not just in the mind, it is also in the heart, soul, conscience, feelings, sensory perceptions, and maybe more, all together.)

5. Originally when I first started writing this book I wrote "and/or" with the slash symbol the way I was taught in school. About halfway through writing this book I decided that the slash symbol looked a little bit obtrusive so I changed it to the dash symbol and left it that way. Since then I have decided that the dash symbol doesn't necessarily look that much better. So now I use a comma in between "and,or" without a space. I think it looks better that way and since I have a tendency to use it quite a bit, similar too "and so on" and "also", I decided to write it the way I want too. As a writer I have to look at it everytime I write it. So, for in most of this book "and-or" will be written with the dash, because for the most part, I left this book in it's original form. However, in the revision section I wrote "and,or" with the comma and that is pretty much how I write it now.

(2010 Revision Note: I went through the rest of the book and changed all the the and-or(s) with the dash to and,or with the commas.)

(Note: I did make some minor changes to some of the other pages, but for the most part they were just small proof reading and,or editing errors that I didn't catch in the original book.)

A Little Bit About The Original Book

When it comes to my original SMARTT Book, I only sold five copies. It went on sale at the end of October 1997. I put out flyers to sell it and I stood on the street selling it from the street corners. I did this for about eight months. The five copies I did sell were from the street corners. I didn't get any orders through the mail. I obviously knew that the SMARiTT people were going to continue stealing my mail from the post office "the family way", however I figured when I got enough orders that it would get too big and they would

eventually have to give me my mail and let it through. “They didn’t”. “Their fault”. “Big” Mistake”.

Not only did they maintain to steal my mail at the post office, but they actually mass produced my book and handed it out to all of the SMARiTT people “the family way”. This is going to cost them some severe damages. Not only will they have to pay for stealing my mail at the post office, but they are going to have to pay for mass producing my book and handing it out to all of their friends and all of the other people in on SMARiTT. “For Real”.

To the SMARiTT people, “In the copyright note on page 3, I said I would win”. “You’ll “Get It”.

To everyone else; They reproduce my book with SMARiTT. Part of the reality of SMARiTT and their domination of society and reality with it is the fact that all computers manufactured in the United States of America and probably the world are manufactured with the capabilities to be monitored, hacked, and recorded right through the wire that supplies it with electricity and, or through eewaves. Not only is everybody’s life, thoughts, feelings, and emotions recorded and stored in the most sophisticated computers in the world, but every keystroke made on every computer ever manufactured in the United States of America and probably the world are also recorded and stored in the same computers.

To further substantiate this fact, I would just like to say that electronic computers have been around at least since about the 1930’s. Most likely even longer. The commercial computer market didn’t really exist until about the early 1980’s. That means that the government had computers for at least about 50 years before regular people had them. That also means that the people who are the government didn’t allow most people to know that much about them and that they maintained complete control and security over them and the people who worked on or with them. This further means that they didn’t allow a commercial market until they could be sure they had complete control over it. Also, the original computers they sold on the commercial market to start with were such extreme fraud it’s unbelievable.

(Note: All of the people who worked on this stuff were owned and controlled under high level government contracts and security clearances. That’s why this stuff was never reported to the people through any media and why none of the people who worked on this stuff could write an informative article about it to educate the people. Furthermore, SMARiTT itself is used to monitor and maintain the security thereof.)

Also, it is obvious that I wrote this book on a computer. They hacked my computer so many times they must of wanted to get caught.

A Little Bit More About Radar.

When I first originally wrote this book I was going to put the date the Wright brothers invented and, or perfected the airplane. I checked several sources to find the actual date, i.e. the year the airplane was invented, but I couldn’t seem to find it. I only checked about two or three sources and then I

decided to leave it out because it wasn't that important to me at the time. The airplane isn't necessarily, directly connected to the SMARiTT system that is used to monitor people. The airplane was and is a major instrument in aerial reconnaissance and high altitude picture taking, but it is not necessarily used to monitor individual people constantly.

The main reason I was going to include this in the "A Short History of Technology" section was to show that radar was being worked on and developed even before the airplane was perfected. This further means that the original intent of the use of radar was not to monitor and track airplanes, but to monitor and track things on the ground. Also, since I couldn't find the actual date radar was invented, it didn't seem so important at the time.

As of now I think I have come relatively close to finding the actual dates the airplane was invented and, or perfected. In my research I have found that in 1900 the Wright Brothers made their first successful manned glider flight at Kitty Hawk, North Carolina. In 1903 they made their first successful, manned, engine powered flight, also at Kitty Hawk. In 1905 they made their first successful, manned, engine powered, long distance flight near Dayton, Ohio.

Radar was being worked on in the late 1800's and the early 1900's. This was before people ever even thought that man could fly, (i.e. before airplanes). Radar works like this; Eeewaves are sent out by a transmitter, they bounce off of an object and they come back to the receiver. The amount of time it takes the eeewaves to go out, bounce off of something and come back is measured by a computer in time. Then the computer converts the amount of time it takes the eeewaves to go out, bounce off of something and come back into the amount of distance the object is away.

For example, suppose it takes one second for the eeewaves to go out, bounce off of an object that is two hundred meters away, and come back. Then it takes two seconds for the eeewaves to go out, bounce off of an object that is four hundred meters away and come back. Then it takes three seconds for the eeewaves to go out, bounce off of an object that is six hundred meters away and come back. In this way, one second of time would equal two hundred meters. Which means one and a half seconds would equal three hundred meters and ten seconds would equal two thousand meters. Then the computer is mathematically programmed and, or calibrated to let the person who is using it know how far an object is away by measuring the amount of time it took the eeewaves to go out and come back and then converts it into the distance.

(Note: The example above is quite simplistic and I just made up my own numbers. Radar really does work in this way, however it is most likely measured in millions of a second and not in seconds. Also, for this example I made it proportional, which means one second of time equals two hundred meters, however, since I have never actually worked with radar, I don't know if the mathematical calculations for radar are proportional or unproportional. It is all in the calibration.)

The frequency and, or the wavelength of the eeewaves determines the mathematical conversion from time to distance. Sonar works in the same exact way. Sonar is the use of sound instead of eeewaves. They just use a computer

to measure the amount of time it takes sound to go out, bounce off of an object and come back. Then the computer converts the time into distance as it was calibrated and, or programmed to measure.

One of the main purposes of this little section is to show that radar was being developed, worked on, and probably invented and, or perfected before airplanes had been invented and, or perfected. Which implies that the original purpose of radar was to see, find, track, and range objects, people, animals, vehicles, and whatever else on the ground. Today most people think of radar only in the capacity of monitoring aircraft, missiles, and things in outer space. They also know of and think of radar as being used to catch people speeding in their cars. Most people don't think of radar as being used to monitor and track people, 24 hours a day, 7 days a week, 365 days a year. However, it is most likely that it was its first and primary intended use. Therefore, not only is radar in the stealth capacity of the fact that eewaves are completely invisible to us and they are used on us and around us each and everyday, but radar is also used in the stealth capacity because most people don't know that much about it and they don't think of it in that kind of way.

Now, for a major point. I don't know when the people using radar to monitor and track people figured out that they could use the eewaves of radar to monitor and hear a persons thoughts, feelings, and emotions. My preliminary educated guess would be somewhere in about the early 1900's. However, I really can't be sure. I tried looking up more about radar, but I only became even more confused as I found too many conflicting dates as to when it was actually being developed and, or perfected.

Radar is simply the use of eewaves to range and track objects. The use of eewaves for television, radio, cellular phones, and other things is simply to transmit a signal, code, or vibration through the eewaves from one place to another. With radar itself, it is possible to monitor and track each and every person, 24 hours a day, 7 days a week, 365 days a year. However, with radar alone everyone would be just a blip on a screen. It is with the use of eewaves to monitor a persons thoughts, feelings, and emotion that they can always know which one of those blips is you. This is done with voice recognition software.

Sound is measured in vibrations. Every single sound and, or tone has a specific vibration. Every single person's voice has its own unique vibration and, or voice print. Whenever you think to yourself, you think in your own voice or vibration. Most people know that their recorded voice is different then the sound of their own voice in their head. The reason for this is because your recorded voice is closer to how other people hear you and when you hear yourself talking, you hear your own voice (vibration) more so inside your head. As I sit hear right now I just experimented with it and I have come to the conclusion that I think my voice sounds the same either when I am thinking it or when I say it out loud. It just sounds louder when I say it out loud. Anyway, back to the main point. Since everybody has their own unique voice which has its own particular vibration, with the proper voice print recognition software, radar, and other computer software to blend it all together, it is more then possibly to track and monitor every single person, 24 hours a day, 7 days a

week, 365 days a year and know where anybody or everybody is at, at all times. Furthermore, all of this information is recorded and stored right in the computers used to do all of this stuff with.

A Final Note About Monitoring People.

Microcameras are installed everywhere. These microcameras are computer controlled. With radar, voice print recognition software, and computer controlled microcameras, not only is it possible to know where everybody is at, every minute of everyday, listen to everybody think, every minute of everyday, but they can also watch you on video every minute of everyday no matter where you are at. All of this stuff is completely recorded and stored in computers. So, even if they are not watching you in real time, they can simply watch your whole life in the recording, over, and over, and over, again. Furthermore, they may even be able to connect with you and, or penetrate your energy, out of time, through the recording. However, in real life, you would be feeling them doing this to you in the time that you were in (in the recording) and not the time that they are in, (sometime in the future) while they are watching the recording of you, that you are in.

(Note: The computers and all the other equipment involved here are just tools and, or a device. It requires many people to program the computers and upload all of your information as well as everybody else's. Once your information is uploaded, the people using it can watch you or anybody else they want, anytime they want. They can also watch anything they want in reality and know who all of the people involved are, i.e., what their names are, where they live, who their family and friends are, how much money they have, what schools they went to, what their birth dates are, and so on, and so on, and so on.)

(Further Note: All of the computers, microcameras, sound wave technology, and all of the other equipment put together can't really watch you. Only the people using it can watch you.)
